The referenced project at 7616 US Highway 421 South, Erwin, was inspected on January 9, 2020 by David LyJordan for compliance with the Physical Plant Rules for Mental Health, Developmental Disabilities, and Substance Abuse Facilities and Services 10A NCAC 27G under Program .5600A, Supervised Living for Adults with Mental Illness, and reviewed per North Carolina State Building Code Section 428.2. On February 28 and March 2, 3 and 8, 2020, we received documentation addressing all deficiencies listed in our inspection comments letter, dated January 15, 2020. We have notified the Mental Health Licensure & Certification Section (MHLCS) that this project was recommended for use, as of March 8, 2020, for a total of 6 clients, all of whom are ambulatory. Ambulatory describes a client who is able to respond and evacuate without verbal or physical assistance.

The next step is review of your policies, procedures and staffing by the Mental Health Licensure & Certification Section. Once the MHLCS is in receipt of this letter and transmittal a Licensure & Training Consultant will call you to schedule a meeting.
