Per conversation with Brad on 032224, we will not charge renewal/permit fees even though the permits have expired.

I spoke with a lady at Highland Construction on 032124 and informed her that we would not charge them a fee this time on this permit. but they needed to call in an inspection within 6 months from today, so there would not be a renewal fee. If we have to charge them it would be the \$150 for all total permits and it would be tied to the building permit. I did inform her that the H and S fee would need to be paid again (\$300) and they would have to submit the paperwork again for review.

Plans for pool have been resent again from Lori Matthews at Highland Const. She will pay the public pool fee and I will forward back to H and S.

I emailed Christina Cox at Spa and Pool World to resend the pool and pool house plans to me separately. She had entered them in the subdivision file by mistake.

Per conversation with Brad today, since customer had to resubmit for health and sanitation for re-review we will allow that to count as progress and they will not be required to repurchase the permits for the building and electrical for the pool permit. I emailed Christine Cox this update. They will be calling in for an inspection shortly.
