DID YOU KNOW? TAXATION AND INSPECTIONS CHANGES

- A vehicle that is subject to a safety or emissions inspection is required to have the vehicle inspected (maximum 90 days early) prior to registration renewal.
- Questions regarding vehicle values and appeals on tax values must be directed to the county tax assessor, not the DMV.
- The appraised value and exemption qualification of a motor vehicle may be appealed to the county assessor in writing by the appeal deadline.





IMPORTANT: To retain plate, liability insurance must be maintained continuously.

GENERAL STATUTE 20-67: requires that you notify the Division of Motor Vehicles within 60 days of any change of address

GENERAL STATUTE 105-330.4(a): In no event will a motor vehicle's registration be renewed unless the taxes on that vehicle have been paid.

GENERAL STATUTE 20-66(j): The Division shall not renew the registration of a vehicle unless it has a current safety or emissions inspection.

NOTE: THE WEIGHT DECLARED ON THIS REGISTRATION MUST BE SUFFICIENT TO COVER THE WEIGHT OF THE VEHICLE PLUS ANY AMOUNT HAULED OR PULLED. IF THE VEHICLE IS OVERWEIGHT, YOU ARE SUBJECT TO A CITATION. A VEHICLE WITH A COMBINED WEIGHT EXCEEDING 26,000 LBS OR HAVING 3 AXLES REGARDLESS OF WEIGHT MUST DISPLAY A FUEL DECAL GS. 105-449.47 (NOT INCLUDING RECREATIONAL VEHICLES)
