Mortgage Insurance reimburses Lender (or any entity that purchases the Note) for certain losses it may incur if Borrewer does not repay the Loan as agreed. Borrower is not a party to the Mortgage insurance.

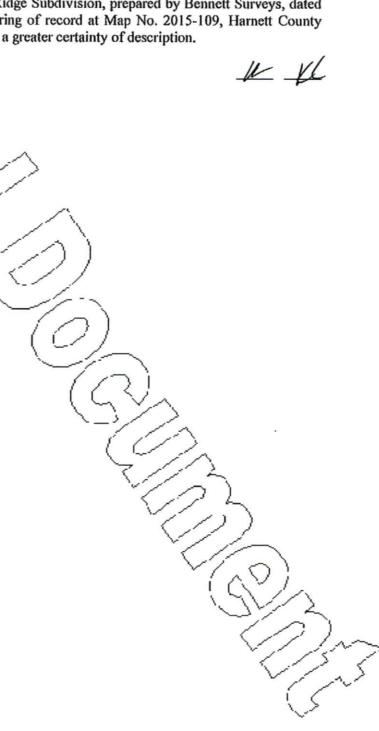
