**WARRANTY  
DEED**

This **WARRANTY DEED** is made the 14th day of January, 2020, by and between **Sue Cameron Pope, widow**, of 566 Cameron Hill Road, Cameron, NC 28326 and **Larry M. Cameron and spouse Linda Cameron** of 3419 Chris Cole Road, Sanford NC 27330 (hereinafter referred to in the neuter singular as "the Grantor") and **Angela Pope Lyon, unmarried**, of 1095 Ponderosa Trail, Cameron, NC 28326 (hereinafter referred to in the neuter singular as "the Grantee");

**WITNESSETH:**

**THAT** said Grantor, for valuable consideration, receipt of which is hereby acknowledged, has given, granted, bargained, sold and conveyed, and by these presents does hereby give, grant, bargain, sell and convey unto said Grantee, its heirs, successors, administrators and assigns, all of that certain piece, parcel or tract of land situate, lying and being in Johnsonville Township of said County and State, and more particularly described as follows:

BEING all of that 1.70 acres as shown on that map entitled "Recombination Survey for William Keith Pope and Dyan Pope" dated November 28, 2018 by Melvin A. Graham, PLS, and recorded on December 21st, 2018 in Map Book 2018, Page 389, Harnett County Registry.

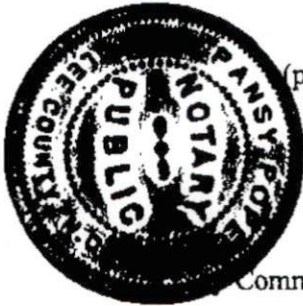
