VI. Additional Details, Terms and Conditions. The Parties agree to any other terms or conditions not stated in this Bill of Sale are as follows:

The bill of sale becomes effective when both parties have agreed and signed in front of the Notary Public and the document has been notarized. The seller hereby sells to the buyer all its interest in the said manufactured home. The buyer agrees to allow seller to maintain possession of the dwelling and continue to reside in the home for the next 45 to 60 days, or until Clayton Homes gives notice the manufactured home needs to be removed from the property, at which time the buyer has one (1) week to remove and relocate said home. All existing decking, underpinning will be removed

by the buyer, at the buyer's expense so the lot free and clear to receive the new home. All existing hook-up (water, sewer, etc.) will be left in tack and usable condition or will be repaired at the expense of the buyer. The sale is final, there are no refunds or returns.
