OK I understand that a copy of this AFFIDAVIT will be furnished to the North Carolina Licensing Board for General Contractors by verification that I am validly entitled to claim an exemption under G.S. 87-340(N2) for the building construction or alteration specified herein. I further understand that, if the North Carolina Licensing Board for General Contractors determines that I was not entitled to claim this exemption, the building permit issued for the building construction or alteration specified herein shall be revoked pursuant to G.S. 87-340, 353 or G.S. 150B-422.

6. OK The building will be solely occupied by the owner(s), firm or corporation as set forth above for at least twelve (12) months following completion.
