- 4. Lots should be kept cut and clear of litter. Garbage containers are provided for your convenience. Each lot number should be 4 In Tall-visible at all times. (From Hwy 55 Hwy 16, 32, 48, 64, 80, 96, 112)
- 5. Harnett County will not allow any unlicensed cars on the lots. Unused tires must be stored out of sight-underpinning required. To protect the well water, no used motor oil, paint ,or chemicals are allowed on your lot.
- 6. Outside Pets are not allowed.-You will be asked to move. Inside pets must be on a leash accompanied by the owner when outside.
- 7. All outside buildings/changes MUST first be approved by the owners and then by the Harnett County planning Department (Telephone 910 893 7525). They do not allow porches or covered decks.
- 8. Two months Lot rent is required as a deposit. It will be refunded when you move if facilities are left clean and undamaged. (Only June rent cololected)
- 9. Rent is due on the first of each month. If it reaches us after the 15th of the month, there will be \$15.00 late fee. Rent Habitually later than the 15th of the month will not be tolerated.
