I understand that a copy of this AFFIDAVIT will be transmitted to the North Carolina Licensing Board for General Contractors for verification; that I am verily entitled to claim an exemption under G.S. 87-1(b)(2) for the building construction or alteration specified herein. I further understand that, if the North Carolina Licensing Board for General Contractors determines that I was not entitled to claim the exemption, the building permit issued for the building construction or alteration specified herein shall be revoked pursuant to G.S. 83A-362 or G.S. 160A-422.

5. The building will be solely occupied by the owner(s), firm or corporation as set forth above for at least twelve (12) months following completion.
