#### **Mixed Debris - 40 yard dumpster rental - 4 ton weight limit**

1. The weight limit on your container is 4 ton(s), and Customer will pay an additional fee of \$75 dollars per ton for all materials and/or weight in excess of 4 ton(s). 2. Customer will pay an additional fee of no less than \$150.00 for any and all unsuccessful container pick-up or drop-off attempts. This includes any reason(s) beyond our control. This fee covers driver's pay, fuel, and time for re-routing the driver's planned schedule. 3. A fee of \$20 per day will apply beyond the "Last day" as stated on this Invoice. You are responsible for scheduling the Equipment pick-up. Call the phone number identified above on this invoice or fill out the "Schedule a Pickup" form located on our website. 4. We will charge a cancellation fee of not less than \$25 if you cancel the order prior to 3 p.m. the business day before delivery, and not less than \$150 if you cancel or modify your order the day of delivery or after 3 p.m. the business day prior to delivery. \*Please note that your equipment can arrive ANYTIME throughout the day on the delivery date. PLEASE DO NOT CALL the phone number on the side of the dumpster. Instead, for ALL SERVICES, call the phone number identified above on this invoice. 5. We cannot accept appliances, electronics, cardboard, stumps or yard waste. Additional fees and charges will be assessed to customer for any such items.

Budget Dumpster, LLC, an Ohio, U.S.A. limited liability company, including its affiliates and subsidiaries ("Budget Dumpster"), agrees to provide certain waste removal services, including the provision of required dumpster equipment ("Equipment") to customer ("Customer") on the basis of the terms and conditions as set forth herein. (hereinafter collectively referred to as "Waste Removal Service(s)" or "Service(s)") Except as specifically set forth herein, or as otherwise communicated by Budget Dumpster to Customer, the following terms and conditions, including the Service Documents (as defined herein) shall apply to and govern both commercial and residential services. 1. Acceptance; Contract Formation. This transaction is expressly limited to and made conditional upon Customer's assent to and acceptance of all the terms and conditions contained herein and as set forth in any related service document, including, but not limited to any quotation, proposal, acknowledgment and/or invoice (collectively referred to hereinafter as the "Service Documents"). The terms and conditions stated herein shall apply to and govern all Service Documents, including any agreement, order and/or Service that may result herefrom, and these terms and conditions, along with the Service Documents, constitute the entire agreement between Budget Dumpster and Customer. Any of Customer's terms contained in any request for quotation, purchase order, release, acknowledgement or any other Customer document which are in addition to or different from the terms contained herein are hereby specifically objected to, rejected and excluded, and shall be of no force or effect. 2. Ordering Process. Budget Dumpster intakes and processes all Service(s) orders either via telephone or via our website which is located at [www.budgetdumpster.com](http://www.budgetdumpster.com) (the "Website"). Customer acknowledges and agrees that upon Customer's placement of an order for service including the provision of the required Equipment (either via telephone or via the Website), and Budget Dumpster's acceptance of such order, then a binding and enforceable service agreement shall exist between Budget Dumpster and Customer with respect to such Service(s) based upon these terms and conditions, as well any applicable Service Documents. All service orders accepted by Budget Dumpster are accepted with the understanding that each such order is subject to Budget Dumpster's ability to obtain and furnish the required Equipment to Customer. Customer is solely responsible for contacting Company (either via telephone or via the Website) in order to initiate the commencement of the Services, as well as the final pick-up of the Equipment (in accordance with the terms of Section 4 herein). Customer acknowledges that any telephone numbers posted on and/or adhered to the Equipment belong to third-parties and should not be used for the purpose of attempting to contact Company. 3. Delivery and Pick Up of Equipment. Budget Dumpster will use commercially reasonable efforts to ensure timely delivery and pick up of Equipment; provided that, due to circumstances beyond our control, including, but not limited to, inclement weather, hazardous roads and/or driving conditions, traffic delays, motor vehicle accidents, delays at landfills and equipment failure, we cannot and do not guarantee delivery times or dates. Budget Dumpster will not be liable to Customer under any circumstances for costs, expenses, losses and/or damages incurred by Customer in any manner relating to such delays. Upon the delivery of the Equipment to the location as designated by Customer, Customer shall not move, transport or attempt to move or transport (either directly or indirectly) the Equipment from the designated site without prior notice to and consent from Budget Dumpster, which may be withheld within the sole discretion of Budget Dumpster. In the event that Budget Dumpster attempts to deliver or pick-up Equipment and is unable to do so for any reason beyond Budget Dumpster's control, including, but not limited to, overloaded Equipment, low lying power lines or tree branches, blocked access to the delivery or pick-up location, damaged Equipment, locked gates, fences or parking lots, inaccessible driveways and/or the storage of prohibited items or substances in the Equipment (collectively referred to as "dry run"), then Budget Dumpster shall be entitled to an dry run inconvenience fee. The standard dry run inconvenience fee is \$150.00; provided that, if Budget Dumpster incurs additional charges, fees, fines, penalties costs and/or expenses related to the dry run, then Budget Dumpster may increase the dry run inconvenience fee in order to recoup any such charges, fees, fines, penalties costs and/or expenses. Customer acknowledges and agrees that Budget Dumpster is authorized and entitled to charge to Customer's credit card the amount of any such dry run inconvenience fee. Customer shall be solely responsible for any fees, penalties, fines, assessments, charges, costs and expenses asserted by a third-party (including, without limitation, a towing company) incurred in connection with the movement, placement and/or use of the Equipment. In the event of Customer's violation and/or breach of the terms of the Service Agreement (including these Terms and Conditions), Company may, within Company's sole discretion and without prior notice to Customer and without any liability to Customer, pick-up the Equipment. In addition, Company may pick-up the Equipment at any time if required to do so by local, county and/or state law or as required by order of any local, county and/or state government or agency. 4. Prices and Payment Terms. Prices for Waste Removal Services are

stated on the Website, as modified from time to time within the sole discretion of Budget Dumpster; provided that applicable prices for each transaction will be confirmed by Budget Dumpster at the time of Customer's placement of an order for such Waste Removal Service. Except as otherwise mutually agreed in writing between Customer and Budget Dumpster, Customer will pay Budget Dumpster monthly throughout the applicable service term via credit card payment. Customer hereby expressly authorizes Budget Dumpster to retain your credit card information and charge your credit on a monthly basis for Waste Removal Service fees and all other charges to which Budget Dumpster is entitled hereunder. Customer acknowledges and agrees that such credit card authorization shall remain valid and in full force and effect during the applicable service period and for a period of time not to exceed 120 days beyond the last day of your Waste Removal Service. If, at any time during a service term, Budget Dumpster's authorization to charge your credit card is revoked and/or cancelled by Customer or any third-party, then Budget Dumpster, within its sole discretion, may immediately terminate the Waste Removal Service and recover the Equipment without notice or liability to Customer, and without prejudice to or waiver of any of Budget Dumpster's remedies against Customer. 5. Cancellation and Cancellation Fees. Any service order, once placed with and accepted by Budget Dumpster, may not be cancelled by Customer except upon the consent of Budget Dumpster, which may be withheld within the sole discretion of Budget Dumpster. In the event that Budget Dumpster agrees to accept a cancellation after acceptance of Customer's order, then Budget Dumpster shall be entitled to a cancellation fee (which may be charged to Customer's credit card) in the amount \$25.00 if the cancellation occurs prior to 3:00 p.m. the business day before your scheduled delivery and a cancellation fee in the amount of \$150.00 if the cancellation occurs thereafter. 6. Weight Restrictions and Overload Fees. Customer is solely responsible for complying with the weight restrictions applicable to the Equipment. Customer acknowledges that: (a) each item/unit of Equipment has a designated weight specification and corresponding weight limitation (which varies based on the size and type of the Equipment, as well as other factors); (b) the size and/or volume of the particular item/unit of Equipment is not determinative of the applicable designated weight specification and weight limitation for such item/unit of Equipment; (c) local, municipal, city, county and/or state laws, regulations, rules and ordinances also govern and limit the weight and/or amount of material that can be legally stored in and/or transported in the Equipment; and (d) rain, water, snow, ice permitted by Customer to accumulate in the Equipment can increase (and under certain circumstances) exceed the applicable weight restriction relating to specific Equipment. Customer acknowledges that Customer is solely and exclusively responsible for determining the weight restrictions applicable to the Equipment provided to Customer and for strictly complying with such restrictions, including, but not limited to covering and/or tarping the Equipment in order to prevent rain, water, snow, ice accumulation in the Equipment. Customer hereby acknowledges that Budget Dumpster incurs charges and expenses in connection with the transport of loaded Equipment to landfills, and that such charges and expenses are based upon the weight of the Equipment. If Customer fails to comply with applicable weight restrictions, Budget Dumpster may incur any pay for charges, expenses, penalties and/or fines from a landfill or other third-party, whether private or public, including, but not limited to traffic fines and penalties or other consequential damages (collectively the "Overload Expenses"). In the event that Budget Dumpster incurs any Overload Expenses relating to or in connection with Customer's failure to comply with applicable weight restrictions, then, in addition to all other remedies to which Budget Dumpster is entitled and in addition to all other amounts, fees, charges and expenses due from Customer to Budget Dumpster (including Customer's reimbursement of all such Overload Expenses to Budget Dumpster), Customer will pay Budget Dumpster a fee not to exceed the amount of \$200.00 per ton in excess of the applicable weight restriction for the Equipment ("Overload Fee"), as determined within the sole discretion of Budget Dumpster. Customer acknowledges and agrees that all Overload Fees assessed by Budget Dumpster against Customer may be charged to Customer's credit card. 7. Permits. Customer acknowledges that certain locations and/or uses of the Equipment may require a permit, license, certification or other local, municipal, city, county and/or state approval relating to the possession, placement, storage and/or transportation of the Equipment (collectively referred to hereinafter as a "Permit"). Customer represents and warrants to Budget Dumpster that Customer (and not Budget Dumpster) is solely and exclusively responsible for obtaining and maintaining all necessary and required Permits relating to Customer's possession and use of the Equipment. In the event that Customer fails to obtain and/or maintain all necessary and required Permits, Company may pick-up the Equipment without prior notice to Customer and without any liability to Customer. 8. Prohibited Substances. Customer acknowledges that local, municipal, city, county, state and/or federal laws, regulations, rules and ordinances prohibit the storage of certain items, materials and substances in the Equipment ("Prohibited Substances").

Prohibited Substances include, without limitation, tires, batteries, tree stumps, railroad ties, chemically treated lumber, paints and lacquers, oils, asbestos, infectious waste, contaminated soils and absorbents, inks and resins, industrial drums, water heaters and water tanks, food waste, fuels, adhesives, refrigerants and other toxic and/or hazardous materials and substances. A non-exclusive list of certain Prohibited Substances is available on Budget Dumpster's Website for Customer's review. Customer acknowledges and agrees that Customer is solely and exclusively responsible for complying with all applicable laws relating to Prohibiting Substances, and Customer shall be liable for any charges, expenses, damages, losses, fines and/or penalties (including, but not limited to traffic fines and penalties) relating to Customer's storage and/or transportation of Prohibited Substances in the Equipment. 9. Indemnification. Customer agrees to indemnify, defend and hold harmless Budget Dumpster, including its officers, directors, members, employees, agents, affiliates, subsidiaries, successors and assigns from and against any and all claims, counterclaims, suits, demands, actions, causes of action, damages, setoffs, liens, attachments, judgments, debts, fines, penalties, charges, expenses, costs or other liabilities of whatsoever kind or nature (collectively, "Losses") asserted or alleged by any third-party arising from or related to: (a) Overload Expenses; (b) Customer's failure to obtain and/or maintain any required Permit; (c) Customer's use or storage of Prohibited Substances in the Equipment; (d) loss or theft of the Equipment; (e) damage and/or destruction of the Equipment during the applicable service term; (f) personal injury and/or property damage relating to Customer's use and/or possession of the Equipment; (g) physical damage to streets, roadways, driveways, walkways, pavement, curbs, wells, irrigation systems, septic systems and/or underground utilities caused by the Equipment (h) Customer's breach of the these terms and conditions or the terms of any of the Service Documents; and (i) any fees, penalties, fines, assessments, charges, costs and expenses asserted by a third-party (including, without limitation, a towing company) incurred in connection with the movement, placement and/or use of the Equipment. 10. Waiver; Limitation of Liability and Disclaimer of Warranties. EXCEPT IN THE EVENT OF THE GROSS NEGLIGENCE OR INTENTIONAL MISCONDUCT OF BUDGET DUMPSTER, CUSTOMER HEREBY WAIVES ANY AND ALL CLAIMS AND LOSSES AGAINST BUDGET DUMPSTER RELATING TO OR ARISING FROM CUSTOMER'S USE OF THE EQUIPMENT AND/OR BUDGET DUMPSTER'S PERFORMANCE UNDER THE SERVICE DOCUMENTS, INCLUDING, BUT NOT LIMITED TO, ANY DAMAGE TO CUSTOMER'S PROPERTY, PAVEMENT, CURBING, DRIVEWAYS, WALKWAYS, LANDSCAPING, LAWN, WELLS, IRRIGATION SYSTEMS, SEPTIC SYTEMS AND/OR UNDERGROUND UTILITIES RELATED TO OR ARISING FROM THE STORAGE OR TRANSPORT OF THE EQUIPMENT IN OR ON CUSTOMER'S PROPERTY, INCLUDING, WITHOUT LIMITATION, ANY DAMAGE TO CUSTOMER'S PROPERTY FROM LEAKS OR STAINS RELATING TO CUSTOMER'S USE OF THE EQUIPMENT. Any provision hereof which may be prohibited by applicable law shall be ineffective to the extent of such prohibition and without invalidating the remaining provisions hereof. 12. Jurisdiction and Venue. Any action arising from or in connection with the Waste Removal Service transaction between Budget Dumpster and Customer, including, but not limited to, these terms and conditions, the Service Documents and/or Customer's possession and use of the Equipment, shall be commenced and prosecuted in the Court of Common Pleas of Cuyahoga County, Ohio, U.S.A., or in the United States Federal District Court for the Northern District of Ohio, Eastern Division. Customer hereby consents to the exclusive jurisdiction and venue of the Court of Common Pleas of Cuyahoga County, Ohio, U.S.A., or in the United States Federal District Court for the Northern District of Ohio, Eastern Division and Customer hereby waives any objection or defense based on improper jurisdiction and/or forum non conveniens. 13. Assignment. Neither this service transaction (including the Service Documents), nor any part or portion of Customer's performance hereunder is assignable by Customer in whole or part without the prior written consent of Budget Dumpster, which may be withheld within the sole discretion of Budget Dumpster. 14. Reservation of Rights. Budget Dumpster expressly reserves all rights and remedies which are available to it at law or in equity. 15. Entire Agreement
