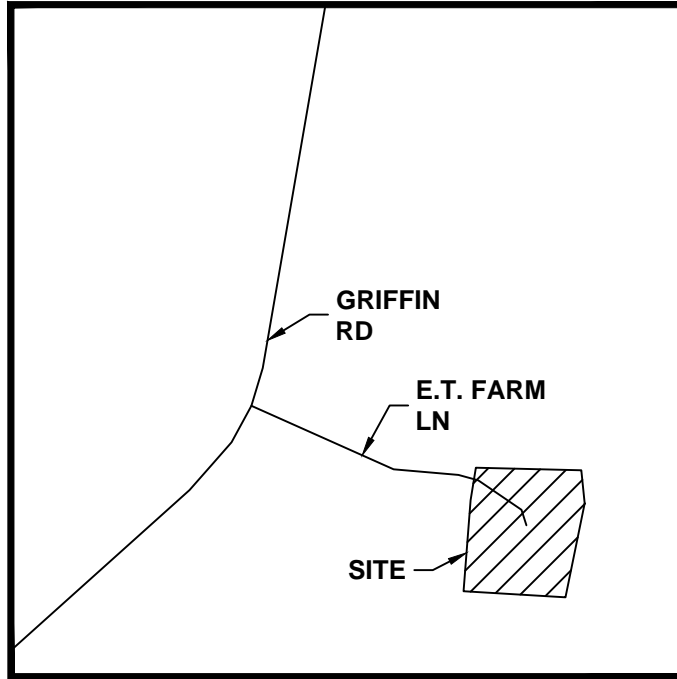


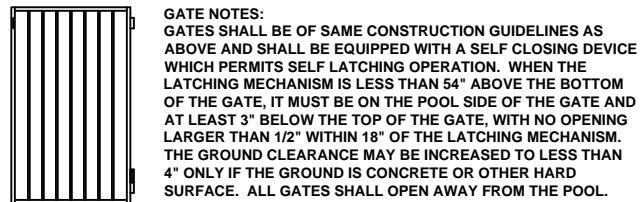
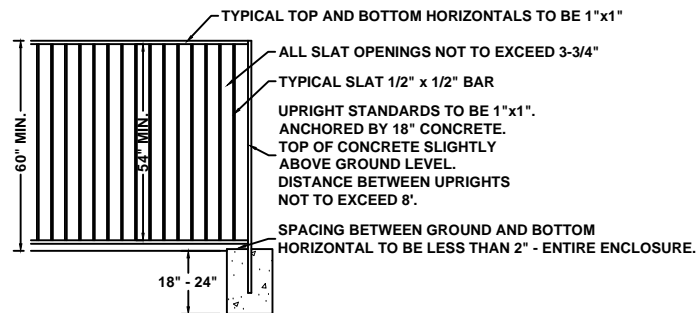
PLOT PLAN

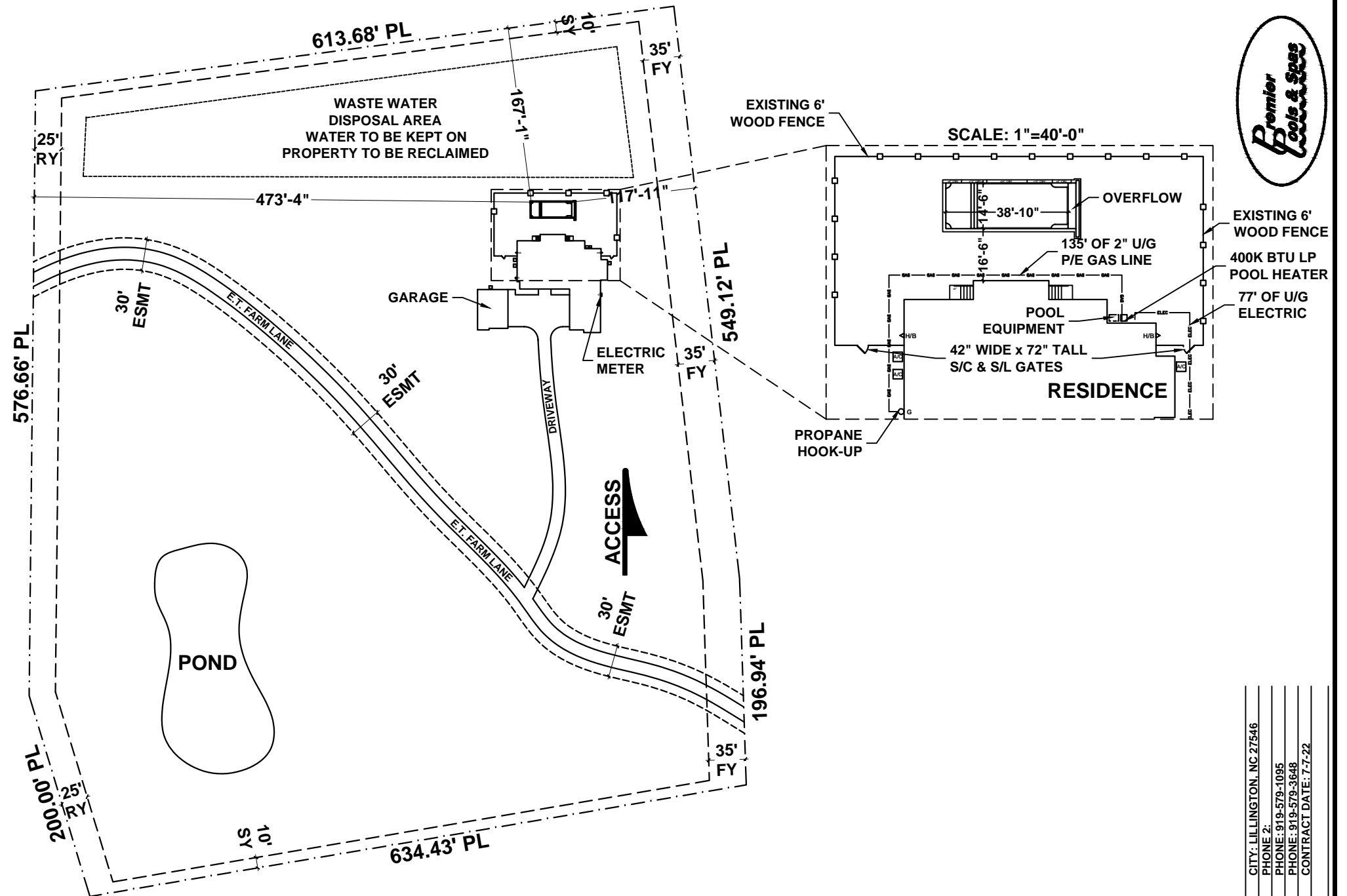

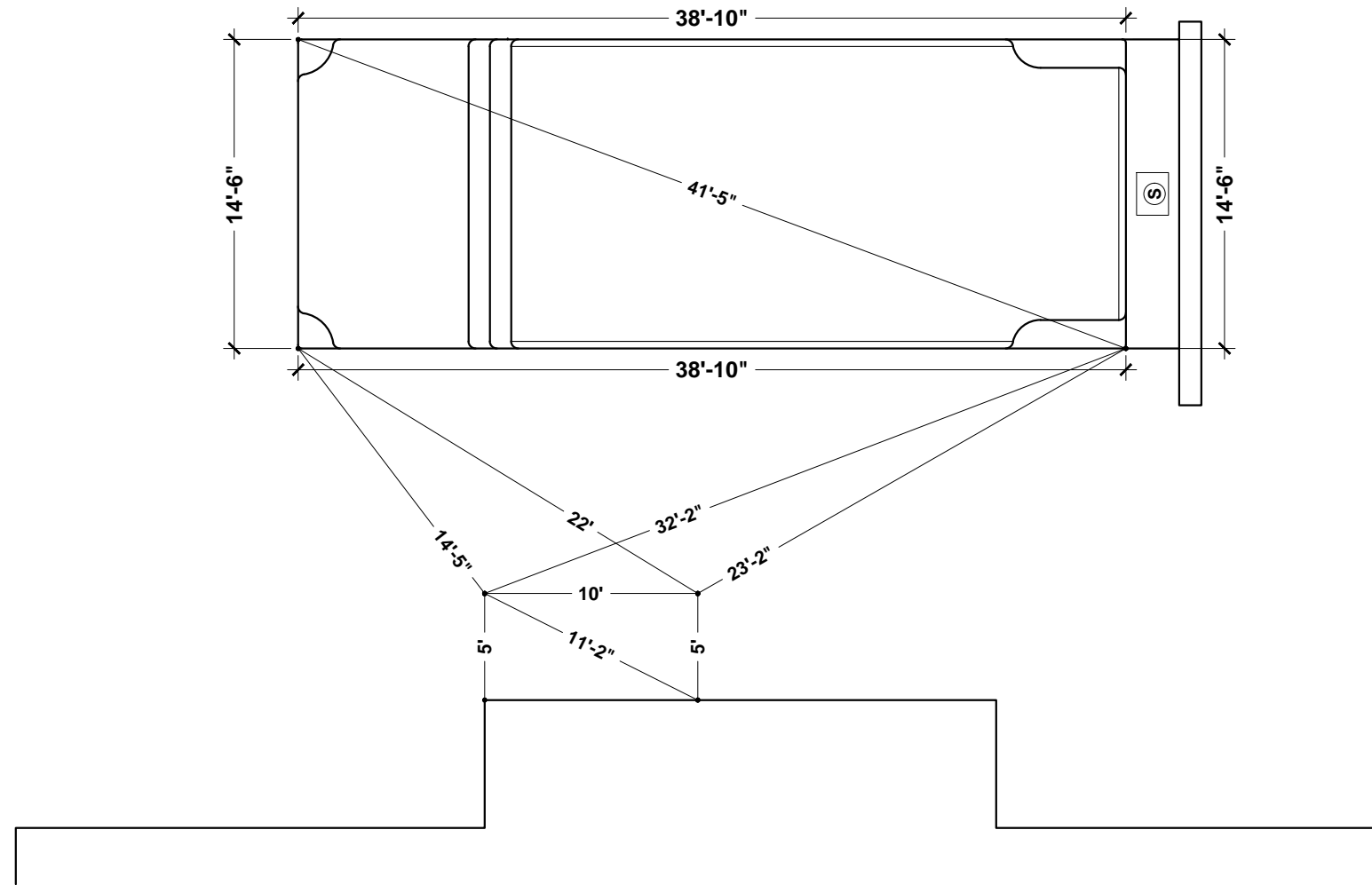

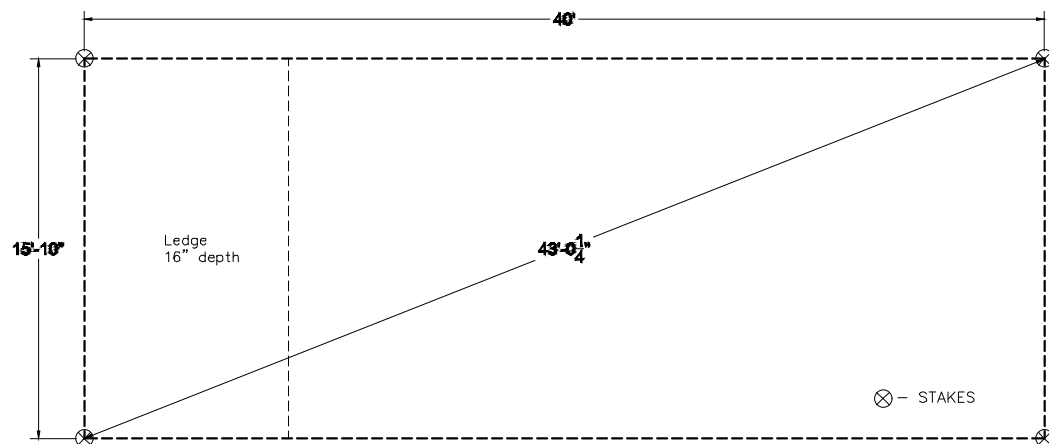

LAYOUT PLAN

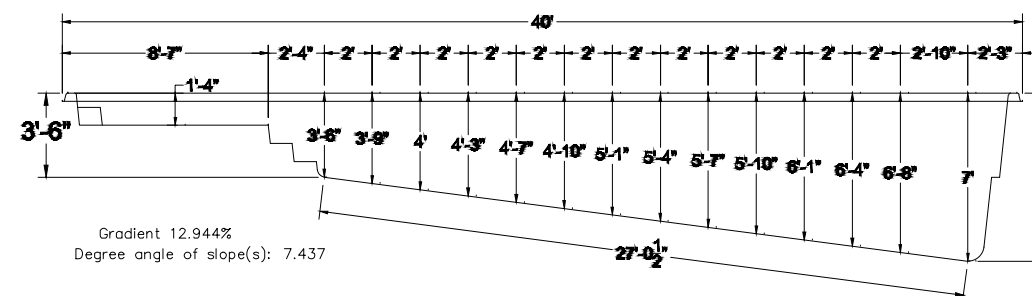
