Narrative:

Dispatched to 445 Arlington Drive reference RSF. 143, 144, and 183 responded. Automatic Aid from BES, ACES, FBE6, SLFD, FBFD, and MC23 responded. 143 arrived and 105 established command while reporting a 2-story structure with light smoke showing, out investigating. Once scene lighting was set up, 105 upgraded the on-scene report to heavy smoke showing form division 1 and all occupants reported out of the structure. a 200-foot 1.75-inch attack line was pulled and entry was made through Division 1 Side A by 143 and FBE6 crews. FBE6 began a primary search while 143 and 1 FBE6 member made an attack. 183 and 144 arrived. 103 assumed command. The fire was quickly brought under control and extinguished with approximately 20 gallons of water. A primary search was completed with nothing found. All units not on scene were canceled. Crews then ventilated the structure with PPV fans. FM was requested and FM4 and FM2 responded. All aid units were released. Crews assisted FM with the initial investigation until released, assignment complete. Nothing further.
