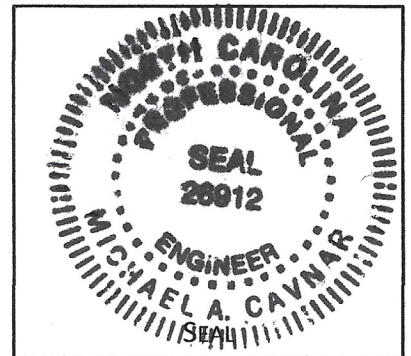
Describe Element/Component/Type of Inspection: ** MONOLITHIC CONCRETE SLAB 24'x30' WITH A TURN DOWN THICKENED PERIMETER OF 1'x1' THAT SERVES AS A FOOTING, THERE ARE TWO NUMBER FOUR REBAR AROUND THE PERIMETER. THE SLAB IS 4" THICK WITH GRAVEL UNDERNEATH THE VAPOR BARRIER. THE CONCRETE USED WAS 3000 PSI WITH FIBER, GRADE SLOPES AWAY FROM SLAB.*
