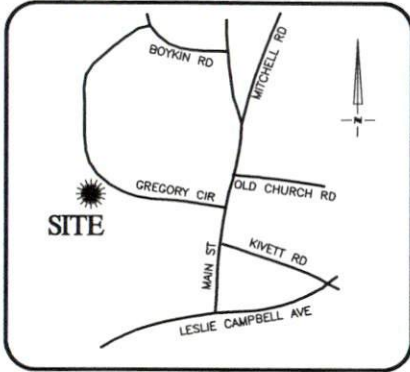

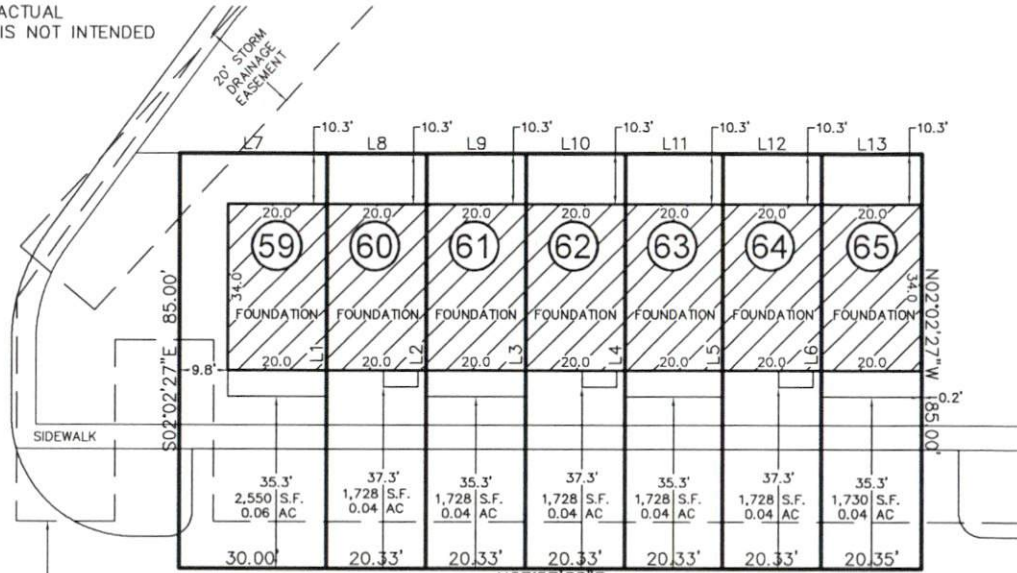
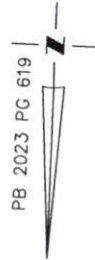
VICINITY MAP

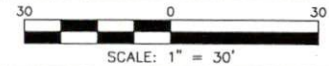
