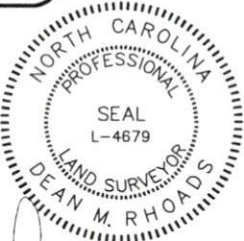
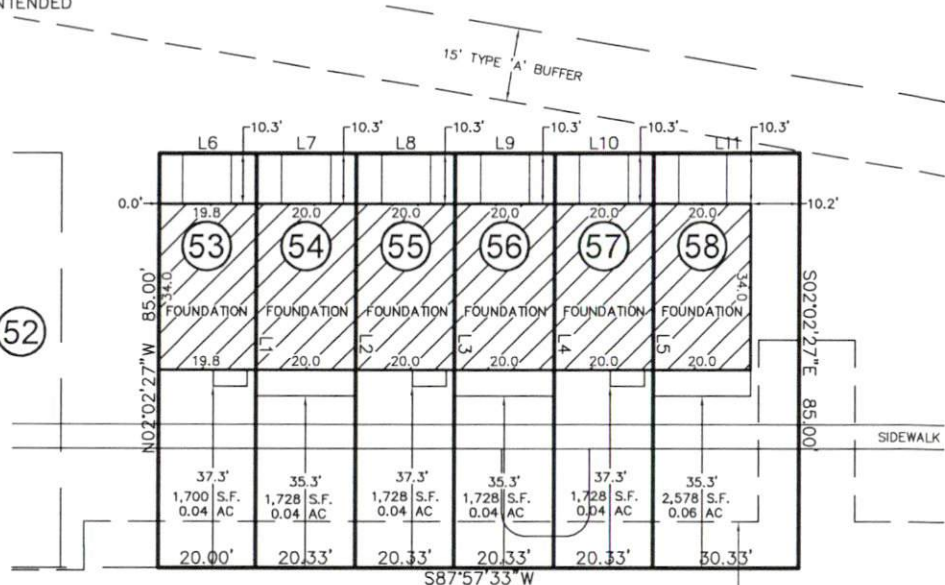
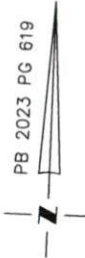
VICINITY MAP
