Footings were 18" x 8" minimum. Interior piers and deck piers were placed in accordance with the foundation plan on-site. Probed footings and piers and found them capable of supporting an allowable soil bearing capacity of 2000 psf. All footings and pier footings extended beyond the 12" minimum frost line. Footings were free of loose soil, organics, and otherwise appeared to be in satisfactory compliance with minimum standards set out in the 2018 North Carolina Residential Building Code. This work was performed in accordance with accepted engineering practices as required by the 2018 NCRBC. Areas inspected were approved for placement of 3000 psi concrete.
