

Specifications

1) Install SmartJack supports as indicated on job drawing to support the floor joist system above. Load Bearing utilizes a custom precast concrete footing on engineering fill. 2) Install exterior discharge line as shown on drawing 3) Complete enrollment in Customer Care program. Includes free annual maintenance and service call trip fees. Sump pumps and dehumidifiers will have lifetime warranties after one year enrollment in program (equipment must be good working order to enroll). Adjustments on SmartJacks, PowerBraces, and Wall Anchors are also included in this program. Enrollees also qualify for special pricing on future projects from Regional. 4) Two Dedicated Electrical Circuits and outlets with GFI protection 5) Install Geo Drain as indicated on the drawing. 6) Install an Everlast door, crawl space door. 7) Install SuperSeal as shown. 8) Install Aprilaire e100 as shown. 9) Install 1.5 inch pvc plumbing from sump pump to location of the discharge line. 10) Install SilverGlo high performance graphite insulation as indicated on job drawing. 11) Remove and dispose of existing insulation. 12) Obtain proper building permit. 13) Required Engineering for permitting documents and Letter of Completion.

Contractor Will

- 1.) Permit Project.
- 2.) Contact utility locator service

Customer Will

- 1.) Move items at least 10 feet away from the work area.
- 2.) Mark any private lines that may be hidden underground, and assumes all liability if damage should occur to such lines.
- 3.) Make payment of remaining balance to foreman of crew the same day installation is complete.

Additional Notes

All recommendations are based on customers descriptions of the problem. While inspection tools such as hygrometers and laser levels are used, no deconstruction or original house plans are available to review for the recommendation. Some unforseen factors may impact project, despite best inspectors best efforts.
