Based on the request of the Contractor, 1 item from the plans was modified. My assessment and recommendations are as follows:

- Item 1: The plans for the Porch Roof call for a post under each end of the LVL ridge for the Porch. Each end of the proposed LVL ridge beam is supported by a double rafter truss style support on each end. The modified truss style support was installed per my recommendation. The modified truss support is acceptable

The 1 item noted above meets all the requirements of the 2018 North Carolina Building Code for Residences.
