Tech observed all foundations were dug to firm bearing soils, and rebar was tied and in place as per plans provided on site. Tech did observe residual water in footing, but soils beneath probed firm with two hands on 1/2" steel probe rod. Tech marked one area of loose soils, which was located in workshop/garage section and suggested contractor excavate loose soils and replace with washed stone prior to concrete placement. Additionally, Tech observed on area of footing on right side of garage that silts had fallen into the footing and would need to be mucked out prior to concrete. Tech advised contractor of areas needing repairs.


Tech observed Monolith slabs, with vapor barrier and insulation boards in place, as evidenced in photos provided.
