Mr. Dunn,

Thank you for submitting the plans for the Building / Sprinkler system addition. The plans have been carefully reviewed by a qualified code enforcement official to examine for compliance with the North Carolina Fire Prevention Code and all other fire protection regulatory documents. There are some items that were found during the plan review process that need to be addressed before a final inspection of the facility can be given. These items are outlined and described below.

• 906.1 Fire Extinguisher(s)

- o A fire extinguisher(s) shall be installed under shelter area.
- Extinguisher shall have a minimum rating of 2A 10B:C and shall not be installed higher than 5 feet above the finished floor or ground.
- Fire extinguishers shall be installed in such a manner that no distance to an extinguisher is greater than 75', this distance can be measured from existing extinguishers on existing buildings.

• 901.2.1 State of Compliance.

- O Before requesting final approval of the installation, where required by the fire code official, the installing contactor shall furnish a written statement to the fire code official that the subject fire protection system has been installed in accordance with the manufacture's specifications and the appropriate installation standard. Any deviations from the design standards shall be noted and copies of the approvals for such deviations shall be attached to the written statement.
- All work shall be performed in accordance with NFPA 13 and the NCSFC.





- 901.5 Installation acceptance testing.
 - O All piping and attached appurtenances subjected to system working pressure shall be hydrostatically tested at 200 psi or 50 psi in excess of the system working pressure, whichever is greater, and shall maintain that pressure without loss for 2 hours. This test is required to be witnessed by a representative from the Harnett County Fire Marshal's Office.
 - A contractor's material and test certificate shall be furnished by the trained representative of Carolina Fire Protection before final approval.
- Penetrations
 - All penetrations in fire rated construction must be UL listed and inspected.
- Notes
 - o A sprinkler system construction permit is required.
 - o Please schedule all inspections through the Fire Marshal's Office.
