2. The outlet end of the tank and distribution box will need to be uncovered and property lines marked. After the tank is uncovered, property lines are marked and orange sign has been placed, you will need to call us at 910-893-7547 to let Environmental Health know that your site is ready for evaluation.
3. The system must be repaired within 30 days or the time set within receipt of a violation letter.

By signing below, I certify that all of the above information is correct to the best of my knowledge. False information will result in the denial of the permit. The permit is subject to revocation if the site plan, intended use, or ownership change.



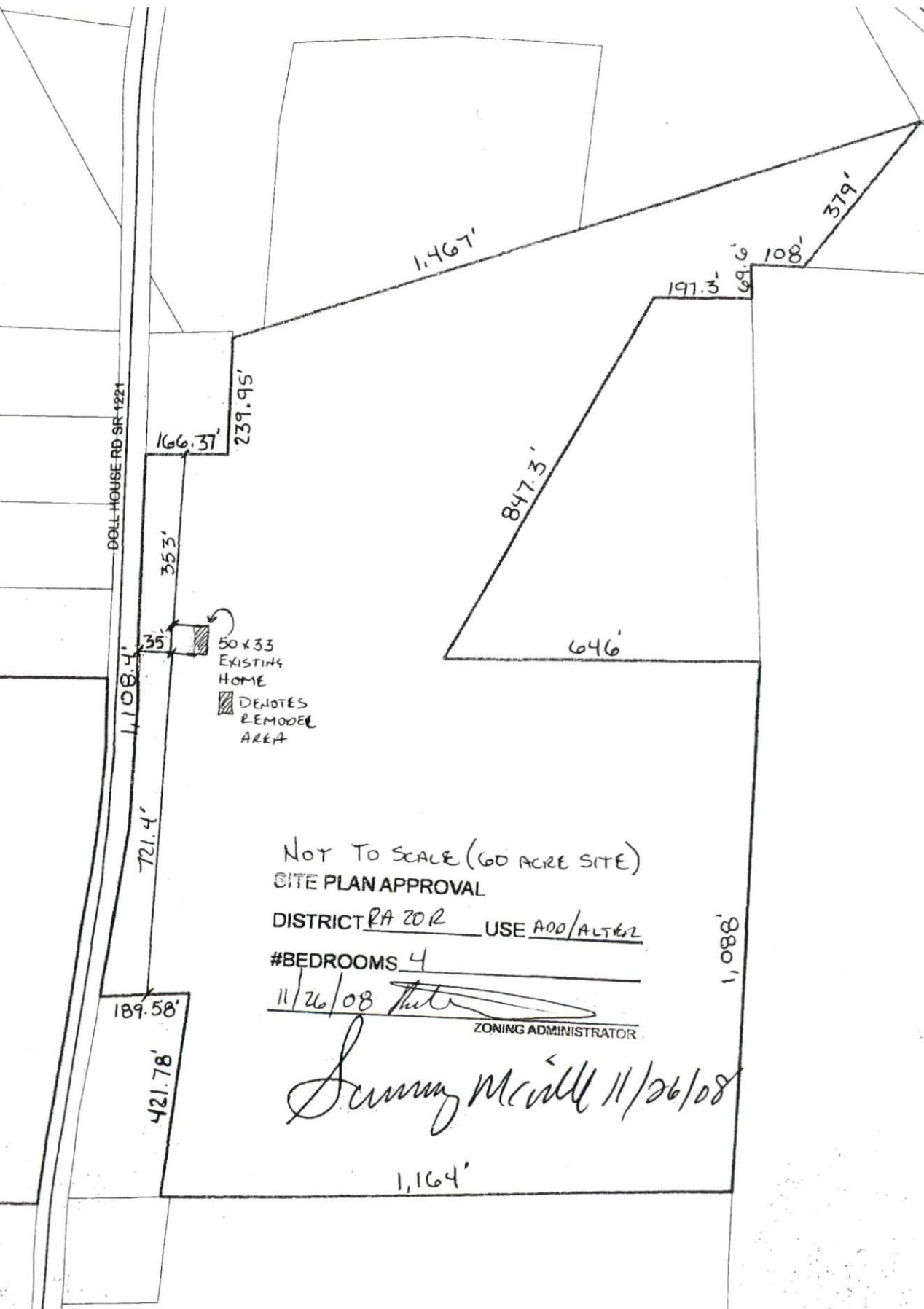

PLEASE READ CAREFULLY

It is your responsibility to have your failing septic system repaired. To help you understand the repair process and upon completing an Application for Repair and supplying us with any and all documentation required by our office you will be asked to complete the following steps:

- ✓ 1. Locate any utility lines that may be underground and/or in close proximity to your tank or lines. If you do not know or are in doubt the number to call is 800-632-4949.
- ✓ 2. Place pink flags (property) on your property lines closest to your system and/or lines.
- ✓ 3. Uncover the distribution box (see attached diagram). You will be required to uncover the outlet end of the tank and break the seal (see attached diagram).
- ? 4. Supply us with a deed with any easements (i.e., utility easement or right of way). It is your responsibility to let us know this vital information.

When calling our office about your application, please indicate that it is a repair.

Once you have completed the above and contacted our office a Environmental Health Specialist will make an on site visit. Once you have received an Improvement Permit you may take the permit to a septic tank contractor of your choice. You have 30 days from the date on the Improvement Permit to complete the repair process by requesting a final inspection for an Operation Permit. Be advised that if you do not receive an Operation Permit within the allotted time frame you will still be in violation and legal action must be taken.
