On December 6, 2001, I visited your site and found a situation that must be corrected before any further soil evaluation can be done.

According to the map submitted by you, the house site is located on a tract of land located approximately 600 feet from SR 1229. You have the house site staked approximately 250 feet from SR 1229. I need to know which is correct. You will need to do either of the following:

- A- Submit a correct plot plan matching your homesite,
- B- Move homesite to match plot plan,

Dear Mr. Swann,

A site evaluation was conducted on McDougald Road. The site has limitations on the type of system that can be installed. These limitations require that a low-pressure pipe system be installed on your lot.

You are required to submit a design for the low-pressure pipe system. The design must come from an engineer or from someone with a working knowledge of this type of system. A field layout of system and repair must also be done. The design must be approved by the Environmental Health Section prior to the issuance of the Improvement Permit.

As of July 1, 1992, a contract must be executed between the system's owner and a management entity (a certified wastewater operator) prior to the issuance of an operations permit. This contract will be for the required maintenance of the system. The contract shall include the specific requirements for maintenance and operation, responsibilities for the owner and the system operator, provisions that the contract shall be in effect for as long as the system is in use and other requirements for the continued proper performances of the system. It shall also be a condition of the Operational Permit that subsequent owners of the system execute such a contract. A copy of the list of Certified WasteWater Operators in Harnett County and the surrounding counties is enclosed for your convenience.
