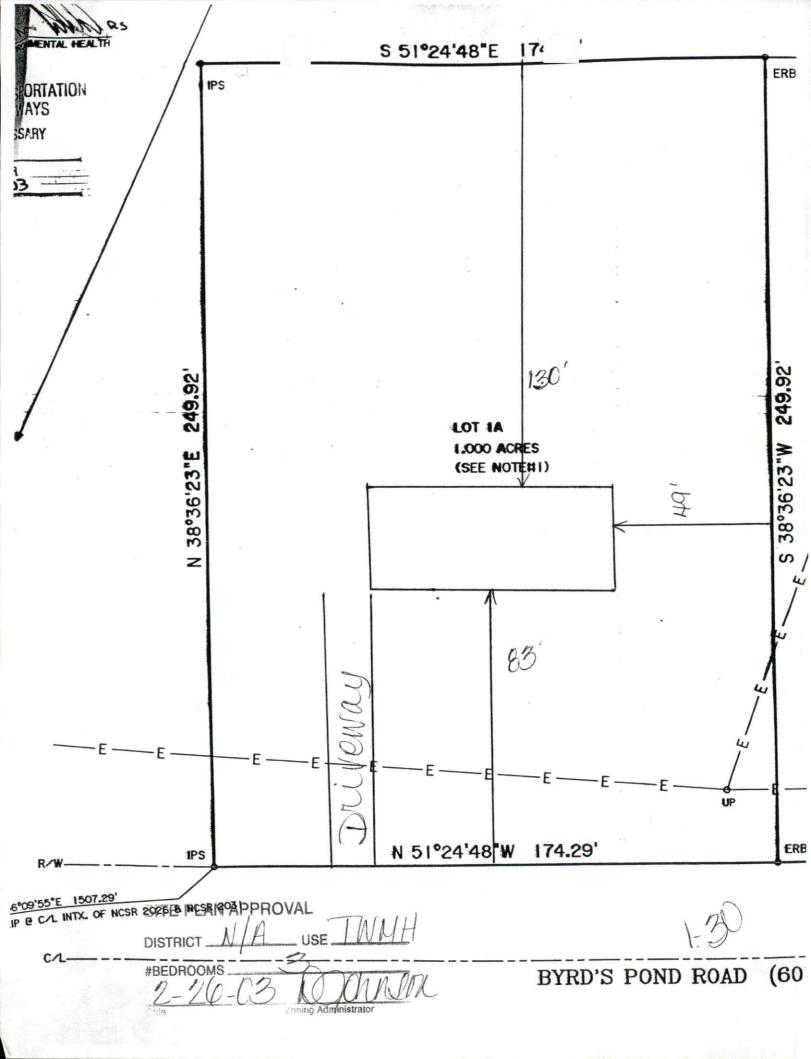

This WARRANTY DEED is made the 5th day of May, 1999, by and between BERTHA S. WITNESSETH:
