Your request received December 11, 2002, concerning the pumping and hauling of wastewater generated from Avery's Body Shop, has been reviewed by the Fayetteville Regional Office.

As explained in your request, you plan to pump and haul wastewater generated by the Avery's Body Shop located in Erwin, Harnett County to the Town of Erwin Wastewater Treatment Plant. The facility indicated their willingness to accept and treat the wastewater in accordance with the December 11, 2002 letter from Mr. Kenneth W. Fail Wastewater Treatment Plant Superintendent. Please be aware that Avery's Body Shop will be responsible for the proper transportation of the wastewater to the designated receiving site. Upon completion of these pump and haul activities, Avery's Body Shop shall provide notification to this office that these activities have ceased.

Please be aware that any environmental impacts that can be attributed to the storage of or the pumping and hauling of the waste noted in your request may result in the Division terminating all pump and haul activities and initiating enforcement actions as called for in the North Carolina General Statutes.


Thanks for your input and help on working out a solution for floor drains on the body shop for Dennis Avery.
