

In order to provide the best customer service, Central Permitting staff compiled a list of procedures that helps to ensure successful permitting processes. Please follow steps necessary to expedite your plans.

Environmental Health New Septic Systems Test

Place "property flags" in each corner of lot: All property lines must be clearly flagged approximately every 50 feet between corners.

• Place "house corner flags" at each corner of where the house/manufactured home will sit. Use additional flagging to outline driveways, garages, decks, out buildings, swimming pools, etc.

• Place flags at locations as developed on site plan by Customer Service Technician and you.

• Place Environmental Health "orange" card in location that is easily viewed from road.

 If property is thickly wooded, Environmental Health requires that you clean out the undergrowth to allow the soil evaluation to be performed. Inspectors should be able to walk freely around site. No grading of property should be done.

• After preparing proposed site telephone Environmental Health (2893-7547) for questions on soil evaluation and confirmation number. Environmental Health will not begin soil evaluations until you call for confirmation number. Environmental Health is the source for all matters concerning testing and scheduling once application is completed at Central Permitting. Please be prepared to answer the following - applicant name, physical property location and last four digits of application number.

• Place Environmental Health "orange" card in location that is easily viewed from road.

· Prepare for inspection by removing soil over door as diagram indicates. Loosen trap door cover.

- At entrance of driveway if home is 100 ft or more from road, or if mailbox is on opposite side of road.
