

I need the following items completed so that I may finish my soil evaluation:

- Surveyor must locate all property corners (true irons) and flag all property lines.
- 2) Clear underbrush from lot so that I may do septic system and repair layout.
- 3) You need to know that the house location, house size, (less than 4 bedrooms), may need to change to fit lot and soil conditions on lot. Septic system has to be 50' from high water mark of the pond. Septic system may require the use of pump, and an alternative type system.
