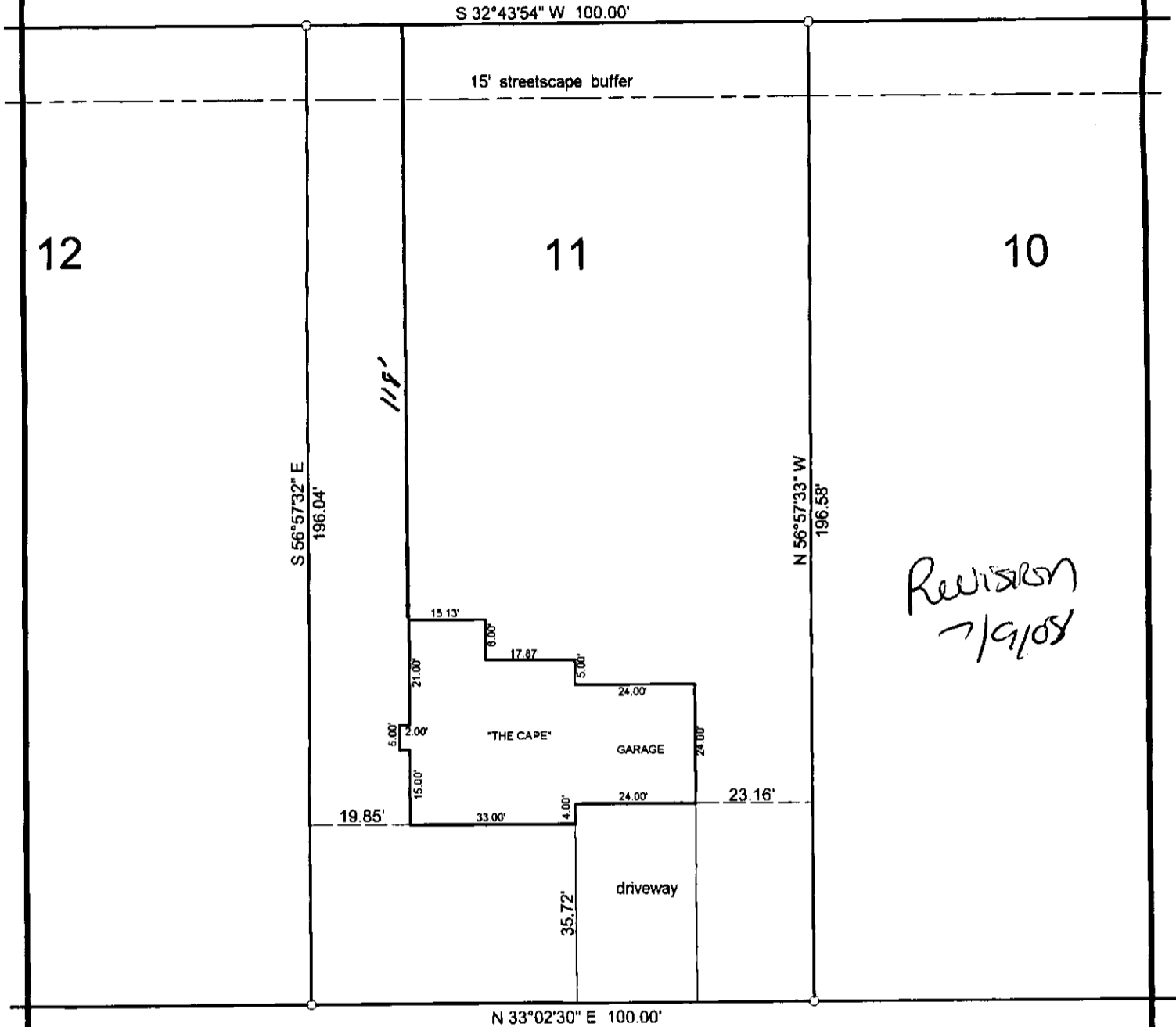

Old Field Loop 50' R/W

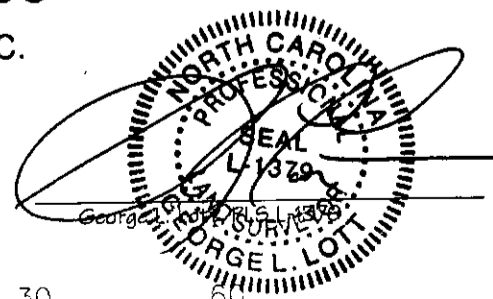
