# Harnett County Department of Public Health Site Sketch

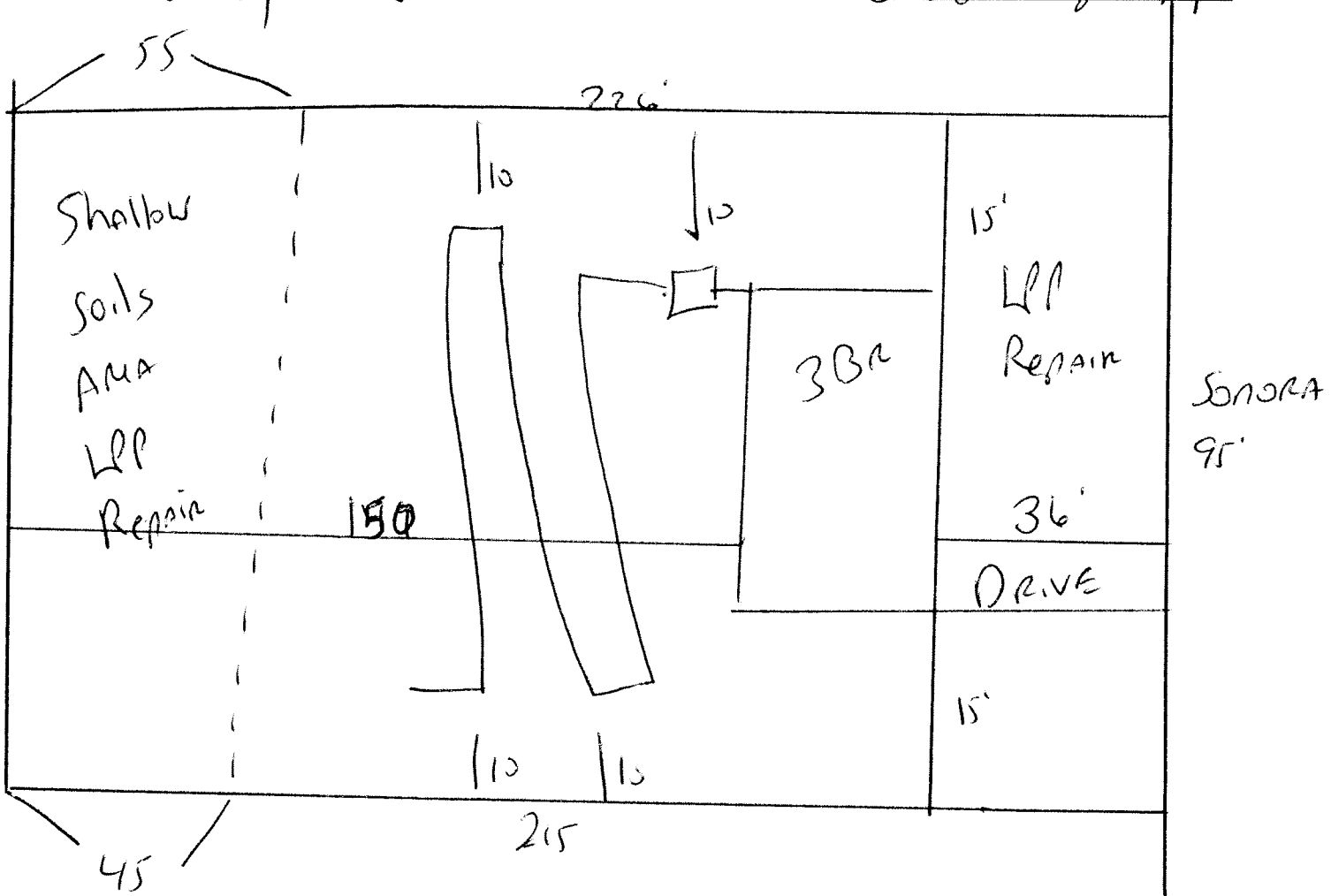
