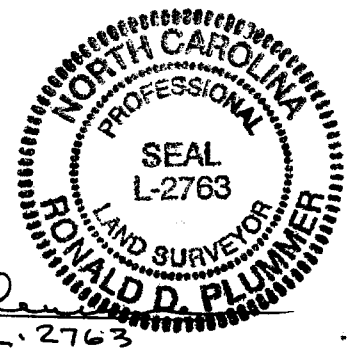

WITNESSETH
