The Harnett County Department of Public Health, Environmental Health Division on March 23, 2009, evaluated the above referenced property at the site designated on the plat/site plan that accompanied your revision. According to your application requesting a barn, the evaluation was done in accordance with the laws and rules governing wastewater systems in North Carolina General Statute 18A.1950 including related statutes and Title 15A, Subchapter 18A, of the North Carolina Administrative Code, Rule.1950 and related rules.

Based on the criteria set out in Title 15A, Subchapter 18A, of the North Carolina Administrative Code, Rules .1950, the evaluation indicated that the site is *UNSUITABLE* for the addition requested. Therefore, your request for a revision is *DENIED*. The site is denied based on the following:

15A NCAC 18A.1950 a (16) Any swimming pool must be 15' from any part of septic system.

\_X\_ 15A NCAC 18.1945 (b) Each lot shall have original septic system plus repair area.

\_\_X\_\_ 15A NCAC 18A.1950 (10) – Any building to be 5' from drain line.

The barn is in the middle of proposed septic area (see attached permit). The area is marked by the blue flags placed on site. You have the option to move the barn out of the septic and repair area.
