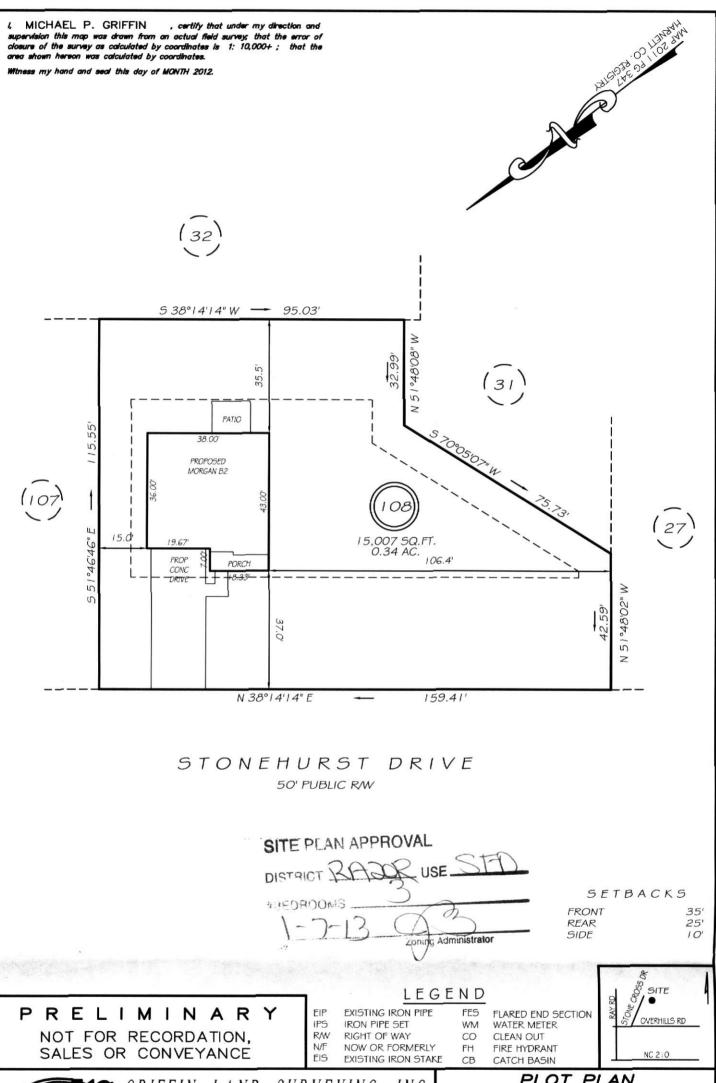
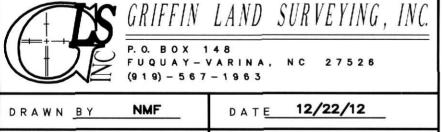

GENERAL WARRANTY DEED

THIS GENERAL WARRANTY DEED, made this the 15th of June, 2012, by and between STONE CROSS, L.L.C. a Delaware Limited Liability Company, doing business in North Carolina as Stone Cross Estates, L.L.C., 125 Whispering Pines Club Drive, Spring Lake, NC 28390 (hereinafter called "Graptor"), and D.R.
