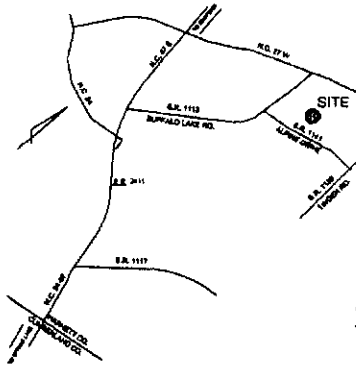

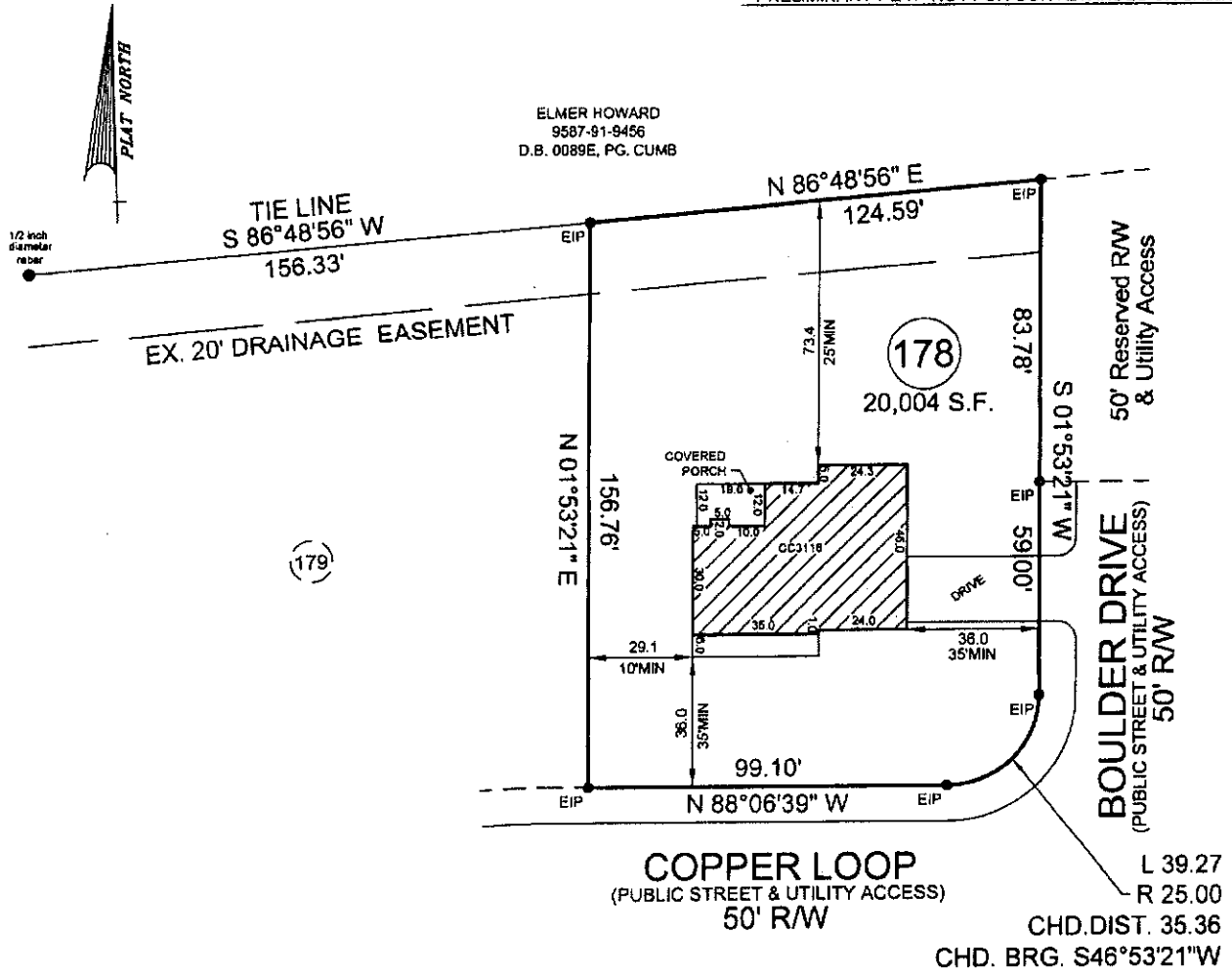


VICINITY MAP
