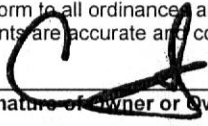

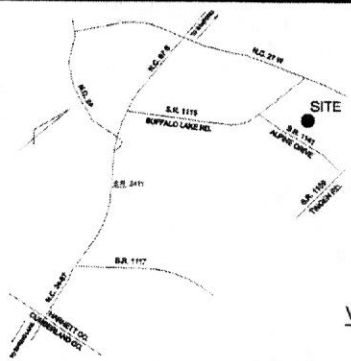

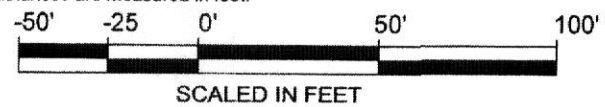
VICINITY MAP
