

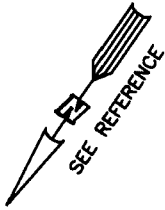

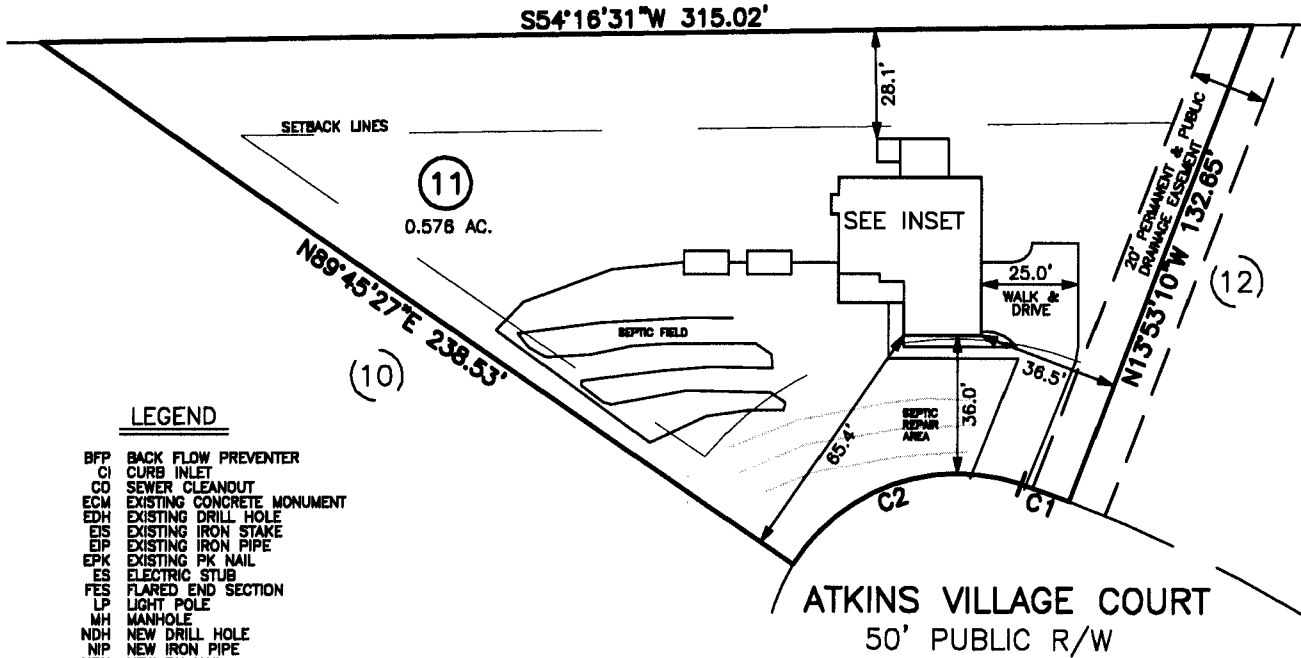

 BLACK RIVER TOWNSHIP, HARNETT COUNTY, NORTH CAROLINA



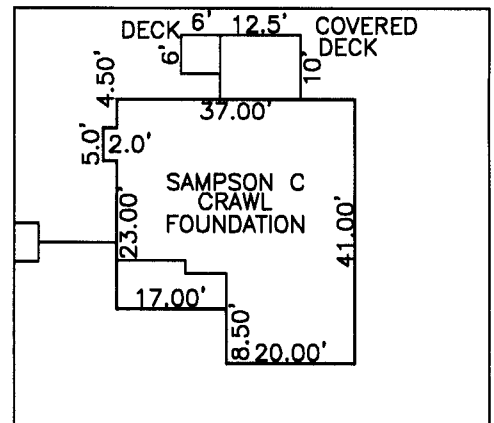
