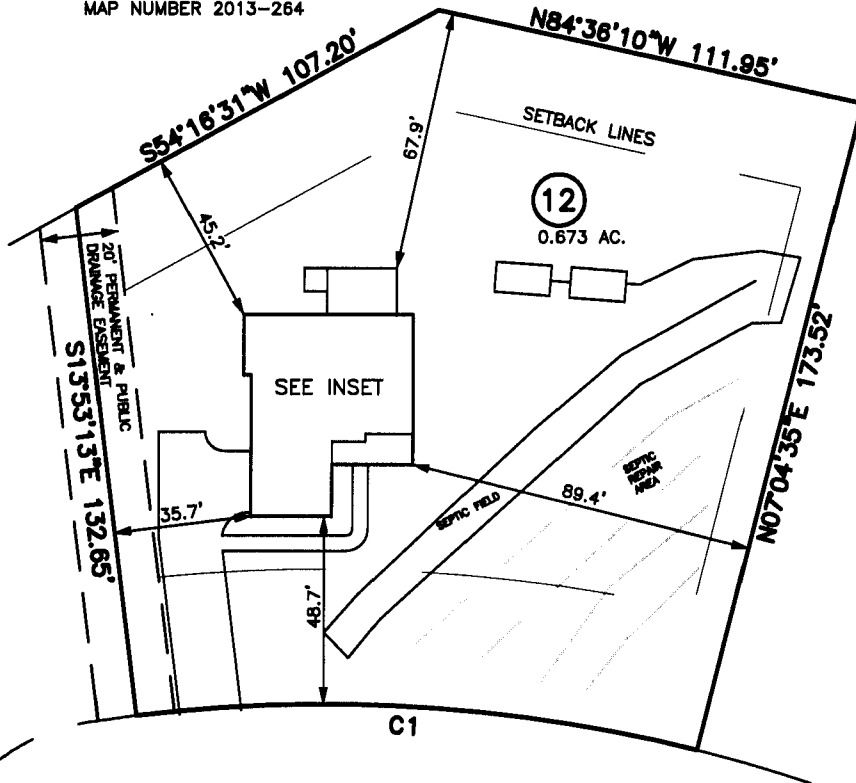

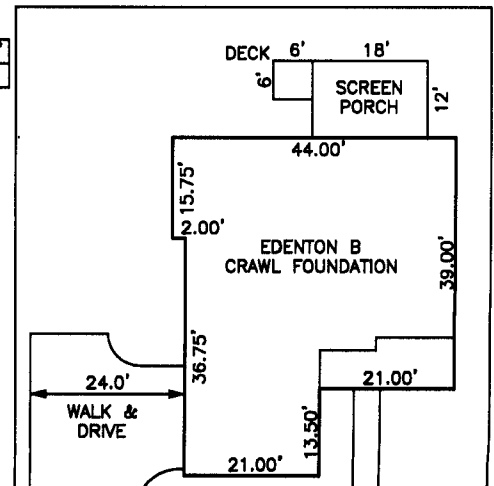

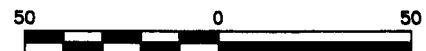

 - Place orange Environmental Health card in location that is easily viewed from road to assist in locating property.
