

Dear Mr. Treadwell,

Per your request, I have reviewed photos of an Anthony glulam column that was installed at the above referenced project. The photos indicate that two holes were drilled through this column. You reported that one ¾" diameter hole was drilled 3 ft from the bottom and a second hole measuring 1" in diameter was drilled 1 ft from the bottom. These holes were drilled parallel to the wide face of the column and the wall in which it was installed. You also reported that this is an Anthony 3-1/2" wide x 7" deep combination 50 column with a height of approximately 9 ft. and calculations provided indicate a total axial load of 9026# or just 48% of capacity.

A conservative estimate based on calculations performed indicate this column, with the holes described above, has a reduced capacity of a maximum of 28%. This is based on an increase in slenderness ratio of 44% and the reduced net section.

This column appears adequate as installed and is sufficient to perform its intended use. No repair is required for the drilled holes described above. Please call with any additional questions or concerns.
