Mr. Sears,

Thank you for sending the plans to our office for review. The plans have been carefully reviewed by a qualified code enforcement officer to examine for compliance with the North Carolina Fire Prevention Code and other fire protection regulatory documents. The listed items are will need to be addressed by the submitting contractor.

• 906.1 Fire Extinguishers

- o Extinguishers shall be type 2A-10BC
- Extinguishers placed in office area may be 5 lbs. in size and place to allow no more than 75 feet travel distance from any portion of the office area.
- Extinguisher in garage area shall be placed in central location and be 10 lbs. in size or two 5lbs placed on opposite sides of garage, an additional extinguisher shall be placed storage area
- o Extinguishers shall be mounted 5 feet off of floor surface
- o Show fire extinguisher locations.
- o Fire extinguishers shall meet the requirements of NFPA 10.
- o Fire extinguishers shall be tagged by a fire extinguisher company.

• 505.1 Physical Address

o The physical address numbers shall be installed on the building and be visible from the road fronting the property.











 A Knox Box is required to be installed on the building for key storage and building access.

• 503.1.1 Buildings and Facilities

O The fire apparatus access roads shall extend to within 150 feet of all portions of the facility as measured by an approved route around the exterior of the building.

Notes

- O Waste oil containers shall be approved and label for the products stored.
- Oily waste shall be in self closing metal cans
- o Tire storage indoor and outdoors shall be subject to NCFC requirements for pile dimensions.
