THIS DEED, made this 8th day of October 1968, by D. R. Blalock and wife, Rena Mae Blalock

to Dewey R. Blalock, Jr., and wife, Brenda Wimberly Blalock

Grantees, all of Harnett County, North Carolina, Witnesseth: That the Grantors, in consideration of Ten Dollars and other valuable considerations to them paid by the Grantees, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey

unto the Grantees, their heirs, or successors, and assigns, the parcel(s) of land in Harnett County, North Carolina, in Black River Township, adjoining the lands of D. R. Blalock,

State Road 1415, and others, and more particularly described as follows:

About two miles northwesterly of the Town of Angier and BEGINNING at a point in the center of State Road 1415, it being North 57 deg. West 115.6 feet from the northwest corner of the new brick veneer residence of Dewey R. Blalock, Jr., and wife, Brenda Wimberly Blalock, and runs thence as the center of said State Road South 2 deg. East 175 feet to a point in the center of said Road; thence South 77 deg. 45' E. 224 feet to an iron stake corner; thence North 39 deg. 30' East 171.5 feet to an iron stake corner with lands of D. R. Blalock; thence North 77 deg. 45' West 300 feet to the point of beginning and contains one acre, more or less, according to map of survey by Jack Stephenson, Surveyor, made Oct. 3, 1968, and being a part of the land which was conveyed to D. R. Blalock and wife, Rena Mae Blalock, by deed of Maude Ava Langdon (divorced) and P. R. Adams (widower) dated Sept. 23, 1953, and recorded in Book 345, Page 532, Registry of Harnett County, North Carolina

This property was conveyed to Grantors by deed dated Sept. 23, 1953 recorded in Book 345 Page 532 Harnett County Registry.

TO HAVE AND TO HOLD the aforesaid parcel(s) of land all privileges and appurtenances thereunto belonging to the said Grantees, their heirs, or successors, and assigns forever.

And the said D. R. Blalock and wife, Rena Mae Blalock Grantor(s), for themselves, their heirs, executors and administrators; covenant with the Grantees, their heirs, or successors, and assigns that they are seised of said premises in fee and have the right to convey the same in fee simple; that the same are free from encumbrances except as herein set forth; and that they will warrant and defend the said title to the same against the claims of all persons whomsoever. The plural number as used herein shall equally include the singular. The masculine or feminine gender as used herein shall equally include the neuter.
