WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in the City of Stewart's Creek Township, Harnett County, North Carolina and more particularly described as follows:

Beginning at a set cotton spindle corner with Dennis O. Fox (Book 767, Page 213-215) located in the centerline of N.C.S.R. 2031 (60 foot right-of-way), said corner being located Southwest 351.64 feet from the dividing line between Alia Mae Jones property and the Dennis O. Fox property, aforesaid corner also being located 0.40 mile Southwest of the centerline intersection of N.C.S.R. 2031 and N.C.S.R. 2072 (60 foot right-of-way); thence leaving the centerline of N.C.S.R. 2031 and as a new line with Dennis O. Fox South 41 degrees 38 minutes 47 seconds East 214.09 feet to a set iron pipe corner; thence another new line with Fox South 54 degrees 29 minutes 29 seconds West 230.93 feet to a set iron pipe corner; thence another new line with Fox North 37 degrees 32 minutes 28 seconds West 184.76 feet to a set cotton spindle corner located in the centerline of N.C.S.R. 2031; thence as the centerline of N.C.S.R. 2031 North 47 degrees 00 minutes 00 seconds East 216.44 feet to the point of beginning and containing 1.02 Acre and being a portion of that Tract deeded to Dennis O. Fox as recorded in Deed Book 767, Page 213-215, Harnett County Registry.

The purpose of this Deed is to convey the life estate of Margie S. Byrd (widow) and the remainder interests of Susan Frances Byrd (Fox) and Charles Gabriel Goodman in order that Grantees herein will hold fee simple title to that tract described above.
