Temporary Service Pole	Temporary service pole.		
Plumbing Ground Work	Installation of all plumbing that will be covered by the concrete floor. A test for this portion of the plumbing system is required.		
Electrical Ground Work	Electrical ground work.		
Footing	Placement of all footing forms prior to pouring concrete. Geotechnical review may be required to confirm soil suitability. If this inspection is performed by 2nd party the engineer letter must be submitted and a footing inspection must still be scheduled.		
Foundation	Construction of foundation, you may be asked to provide a foundation survey to move forward with your inspections.		
Slab	Slab, indicate in your inspection notes what type of slab (mono/stem wall).		
Framing Rough-In	Construction of all structural framing and stairs. (Rough of electrical, plumbing, heating/ac and doors windows & roofing installed.) Must request the trade roughin inspections.		
Rough-In All Trades	All electrical, mechanical, plumbing roughins. Must also request framing inspection.		
Insulation	Installation of the insulating material and vapour barrier. Blown-in insulation can be installed after the ceiling drywall is applied and confirmed at the Occupancy inspection.		
Open Floor Framing	Open Floor Framing, all joists must be visible, attach joist drawings to permit file.		
Gas Piping/Pressure Test	Gas Piping/Pressure Test, used for new install units from heat pump to gas, generator installs.		
Water & Sewer Service Utilities	Installation of new water and sewer service.		
Sanitary Sewer	Installation of sanitary sewer from the property line to the interior of the building. A test for this portion of the plumbing system is required.		
Electrical Final/Reconnect Service	Electrical Final & reconnect service, This inspection is also used for single trade permits.		
Plumbing Final	Installation of all CSA approved plumbing fixtures and hot water tank (water meter must be installed). A test for this portion of the plumbing system may be required. This inspection is also used for single trade permits.		
Mechanical Final	Mechanical final, all duct work must be installed, hvac unit and components installed. This inspection is also used for single trade permits.
