No new land usage may be initiated until a zoning permit and any other required permits have been issued by the Town of Lillington.

Sketch Plan Checklist:

All applications for permit shall include a sketch plan. A sketch plan shall be drawn to an accurate scale (i.e. 1" = 50) and illustrate in simple sketch form the dimensions of the lot on which the proposed building or land use is to be constructed or conducted and the following:

X	The actual shape and dimensions of the lot to be built upon or used and total acreage in the lot.
	Any known environmental conditions (floodplain, wetlands, impervious surface limitations, etc.)
100,000	Proposed layout of existing and proposed streets or drives.
X	_ The location of the proposed structure or use on the lot.
	_ The exact location and size of existing structures and uses.
	_ The existing and intended use of each structure or portion of structure.
_	The number of dwelling units the building is designed to accommodate, if applicable.
	The height and number of stories of the structure(s).
	_ The location and design of any off-street parking and / or loading.
	The location and dimensions of driveways. For state-owned roads, an approved driveway permit from the North Carolina Department of Transportation (NCDOT) shall be required.

Building Trade Permits

The Town of Lillington issues all trade permits for work within the corporate limits or the extraterritorial jurisdiction (ETJ). Harnett County Inspections is contracted by the town for plan review and inspections. Construction plans for review are submitted *directly* to the Town of Lillington. Plans are subsequently transmitted to the county for review after zoning approval. Fire Marshal Review

The Town of Lillington contracts with the Harnett County Fire Marshal's Office for projects requiring fire code approval. Fire code plan review applications are *permitted separately and submitted directly to the county for review*.
