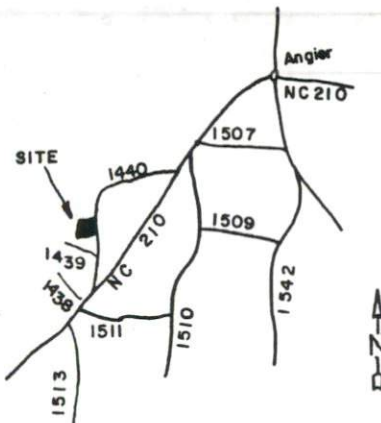
Place stakes at the exact location of dwelling and at each corner of lot.

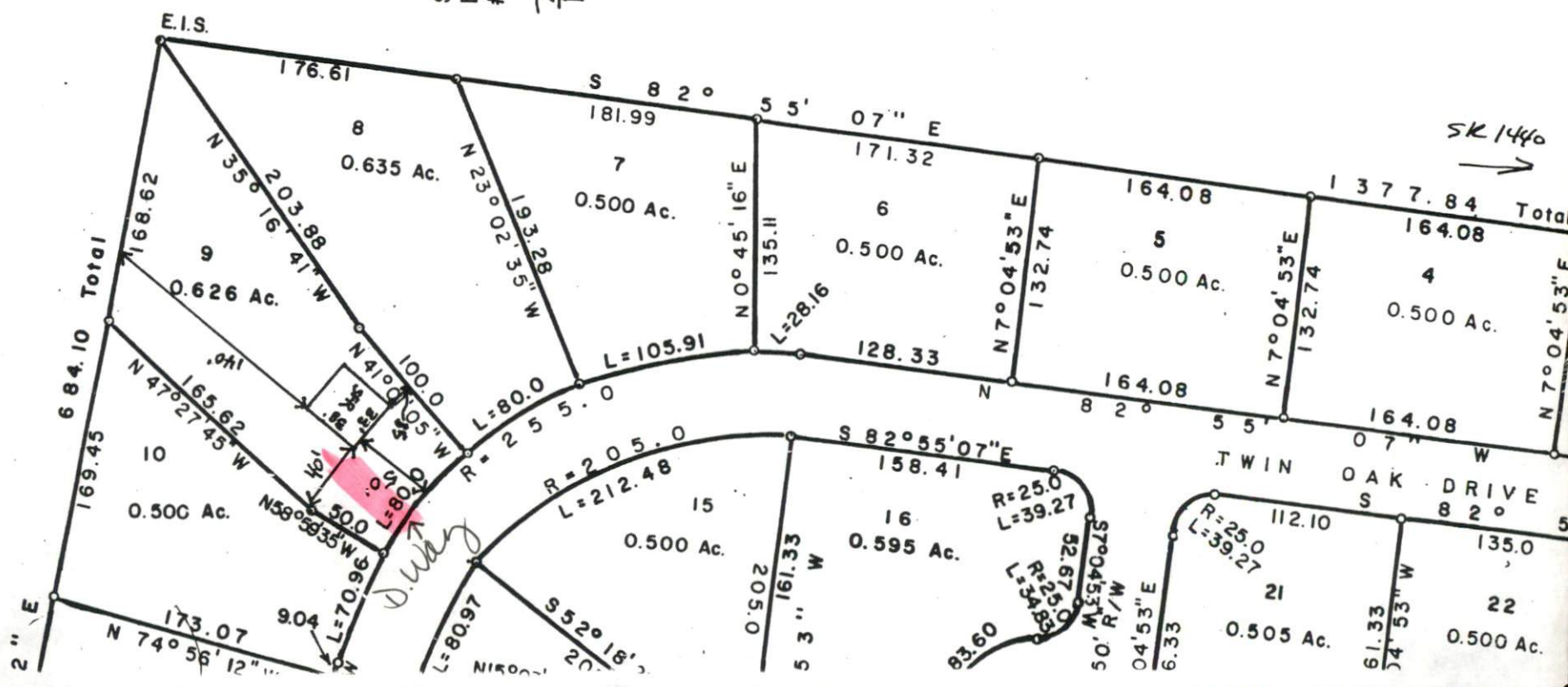
VICINITY MAP
