3. The system must be repaired within 30 days or the set time within receipt of a violation letter.

This certifies that all of the above information is correct to the best of my knowledge. False information will result in the denial of the permit. The permit is subject to revocation if the site plan, intended use, or ownership change.

McLAMB, of Harnett County, North Carolina, and CARWAY INVESTMENTS, INC., a corporation organized and existing under the Laws of the State of North Carolina with its principal office at Dunn, Harnett County, North Carolina, parties of the first part, to WILLIAM J. SPARKS and wife, VICKIE H. SPARKS, of Harnett County, North Carolina, parties of the second part;

W I T N E S S E T H:

That said parties of the first part, in consideration of One Hundred Dollars and other valuable considerations to them paid by said parties of the second part, the receipt of which is hereby acknowledged, have bargained and sold and by these presents do bargain, sell and convey to said parties of the second part, their heirs and assigns, that certain lot or parcel of land lying and being in Duke Township, Harnett County, North Carolina, bounded and described as follows:

BEGINNING at a stake in the original southern line of the 68-acre Sidney Dorman Tract of which this is a part, which stake is located South 74 deg. 23 min. West 900 feet from the intersection of said southern line of the original tract with the west margin of N.C. Highway No. 82, and runs thence North 19 deg. 33 min.
