After receiving an additional complaint, I made on-site inspection of your property and found that a system is failing at 170 Cattie Drive.


Again, you are hereby notified that you are violating the Rules and Regulations adopted by the North Carolina Commission for Health Services in accordance with requirements of Article 11 Chapter 130A-335 (a) of General Statutes of North Carolina. A person owning or controlling a residence, place of business or a place of public assembly shall provide an approved wastewater system. A wastewater system may include components for collection, treatment and disposal of wastewater. You are required to correct this problem within 30 days of receipt of this letter.

Please be advised that any action you may take without an improvement permit does not absolve you of the responsibility for correcting this public health problem, according to health department standards.

I request that you contact the Health Department within **5 days** to discuss your plan of action concerning this matter. **If you fail to meet the requirements for this final notification, this matter will be turned over to the attorney that represents Harnett County for legal action to be taken. The continuation of this violation may constitute a health hazard.**
