3. The system must be repaired within 30 days or the set time within receipt of a violation letter.

Hugh Green on the north, and N. C. State Road No. 1542 on the west, better described as follows:

BEGINNING at a common corner between Corlis Johnson, Ollie Faye Gardner, Mrs. Mary Green Johnson, D. Hugh Green's original corner, and runs as a line between D. Hugh Green and Mrs. Mary Green Johnson North 17 degrees 30 minutes East 135.0 feet to an iron stake in said line (old bearing on this line - North 15-3/4 E); thence a new line with D. Hugh Green North 68 degrees 26 minutes West 279 feet to a nail in the pavement about the centerline of the road; thence along the road South 27 degrees 09 minutes West 225 feet to an iron pipe about one foot from the edge of the pavement on the east side of the road, said point being in Corlis Johnson's line, also D. Hugh Green line; thence as Johnson and Green's line South 84 degrees 30 minutes East 323 feet to the beginning and containing 1.12 acres, more or less, according to a survey made March 19, 1966, by H. T. Turlington, Registered Surveyor.
