### DEED RESERVING LIFE ESTATE

THIS DEED, made this 20th day of April 2005, by and between *Thelma P. Lockamy*, Widow, 1293 Pope Road, Dunn, North Carolina 28334, hereinafter called Grantor and John P. Lockamy 330 Christmas Tree Road, Dunn, North Carolina 28334, Carrie Lynn L. Lee 682 NC 55 Hwy., Dunn, North Carolina 28334 and Faye L. Godwin, 5117 Grey Dove Lane, Garner, North Carolina 27521, as joint tenants-in-common, hereinafter called Grantee;

#### WITNESSETH:

That the Grantor, for and in consideration of the sum of TEN DOLLARS (\$10.00) and other good and valuable considerations to her in hand paid by the Grantee, the receipt whereof is hereby acknowledged, but subject to the life estate herein reserved by the Grantor, Thelma P. Lockamy, has given, granted, bargained, sold and conveyed and by these presents does give, grant, bargain, sell, convey and confirm unto the Grantee, their heirs and/or successors and assigns, premises in Averasboro Township, Harnett County, North Capolina, described as follows:

TRACT ONE: (PARCEL A) (PARCEL #1515-93-6719) BEGINNING at a stake in the Pope Road and C. E. Pope's corner and puns North 89 degrees 10 minutes East 1066 feet to a stake; thence South 1 degree East 238 feet to a stake; thence North 89 degrees 45 minutes West 771 feet to a stake in ditch; thence North 8 degrees West 100 feet to a stake; thence North 85 degrees 10 minutes West 295 feet to a new corner in Pope Road; thence North 3 degrees 30 minutes East with Pope Road 99 feet to the BEGINNING and containing 4.8 acres, more or less.
