CONSTRUCTION PROPOSAL

We hereby submit estimates and specifications for construction of a 12'x20' sunroom addition to the home above. All work will be done in accordance with State and Local building codes.

Blaylock Builders will obtain permits, coordinate subcontractors, and arrange for inspections as needed. Jobsite will be kept reasonably clean and safe, with trash contained and hauled away as necessary, for job duration.

SCOPE OF WORK – (See attached drawings if applicable)

- Existing deck will be completely removed, including support posts.
- Foundation will be brick and block, with brick chosen to match home as closely as possible. A 96 square foot grilling patio will be poured, and room will have brick steps onto the patio. Soil will be pre-treated against wood-destroying insects.
- All framing done according to code and will accommodate six new window units and one door unit (as per attached drawing). Existing entry door will be eliminated; existing 3/0 twin window will be replaced with a new fiberglass insulated French-style door unit.
- 4. New roof system will be stick-framed with 2x12 rafters to accommodate R30 insulation. Room will have a vaulted ceiling with approx. 2ft flat section in the peak (for collar ties). Roofing material will be metal roofing, to include covering the existing bay window which will become a portion of the new roof. Metal roofing color to be chosen by Homeowner.
- 5. Exterior boxing/siding will be vinyl to match existing home as closely as possible.
- 6. Sunroom windows will be 5ft tall low-E vinyl sliding window units. NOTE: 6ft tall units can be used for an additional charge of ~\$322 dollars. New single entry door will be insulated fiberglass one-lite (full view) door unit. New interior French doors (that will replace existing twin window) will match the new entry door.
- 7. Floor, walls, and ceiling will be insulated as per building code.
- Interior walls will have drywall covering taped, bedded, and finished. Ceiling will have beaded ceiling panels painted or stained to Homeowner's preference.
- Electrical standard installation to include one bracket light outside the new entry door and one ceiling fan provided by Homeowner. There will be a separate 110-v circuit to supply the mini-split HVAC system.
- Room will be heated/cooled with a 9,000-BTU mini-split heat pump.
- 11. Finished floor in the sunroom will be LVT vinyl flooring chosen by Homeowner with a materials purchase allowance of \$2.50 per square foot (installation is already included).

TOTAL PRICE: \$29,550.00

(Twenty-nine thousand five hundred fifty & 00/100 dollars)

<u>Pay schedule</u>: 30% down payment upon signing of this Proposal; 30% when foundation is in place; 20% with roughin inspections; Balance on completion.
