Hi Jay,

Thanks for the info. Our house already had a pre-existing boat slip and dock before purchase as well as an outdoor light. The only "new" thing we are trying to do is install a boat lift/motor.

I can certainly send you the dimensions of the boat lift. Just to confirm, you indicated you just need the motor and outlets 2' above BFE. So do we need a surveyor to come out twice (once to mark BFE and second to check the outlet elevation)? As you can imagine, they are expensive.

Also, what do you need to at least inspect the electrical "rough-in" in the ground electrical conduit?

I appreciate any clarification you can provide so I make sure I'm not duplicating any steps in this process or spending unnecessary money.
