## To Whom It May Concern:

Pursuant to your request, we have reviewed the installation of the above-referenced solar panel system. As you are aware, this office initially prepared a structural assessment, dated March 24, 2022, of the solar panel installation. This installation was inspected and found to be in compliance with the layout plan as specified in our report, product installation criteria, and the requirements of the current building codes. The installation is in compliance with the 2018 North Carolina Residential Code Book, professional engineering assessment and judgment and covers this dwellings assessment for solar panel connections and support only. We have determined that the equipment will not create a negative impact on the building's structural design, including any additional loads imposed (dead, snow, wind).

This letter pertains only to the panel support attachments to the roof framing and not the engineered photovoltaic panel products, components, or electrical-related installations/connections.
