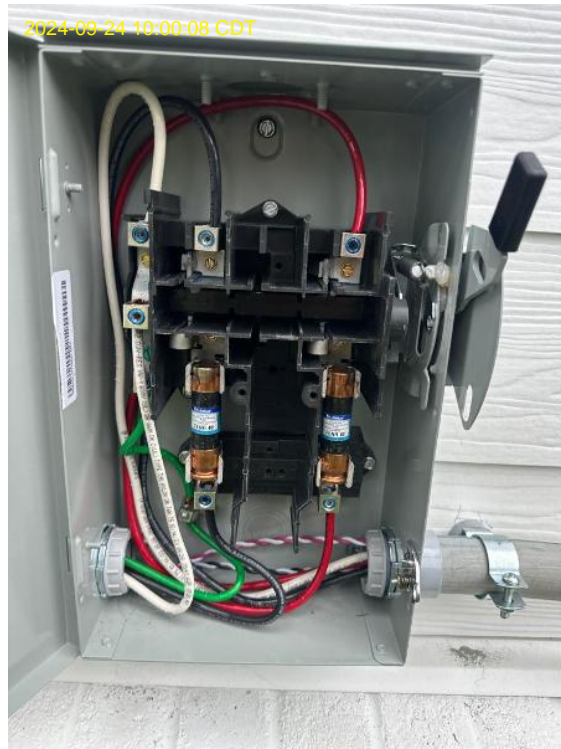

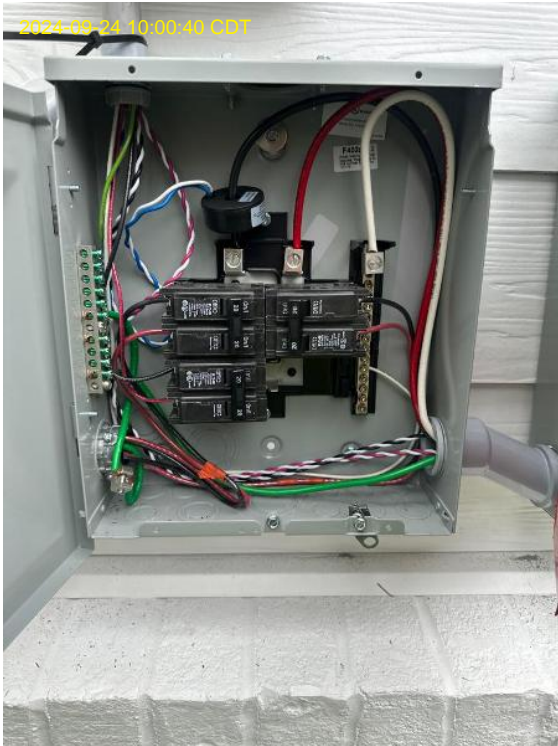

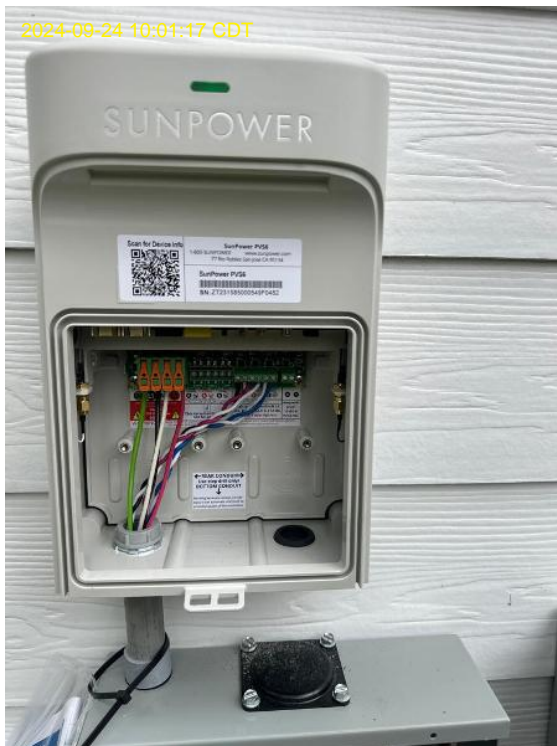

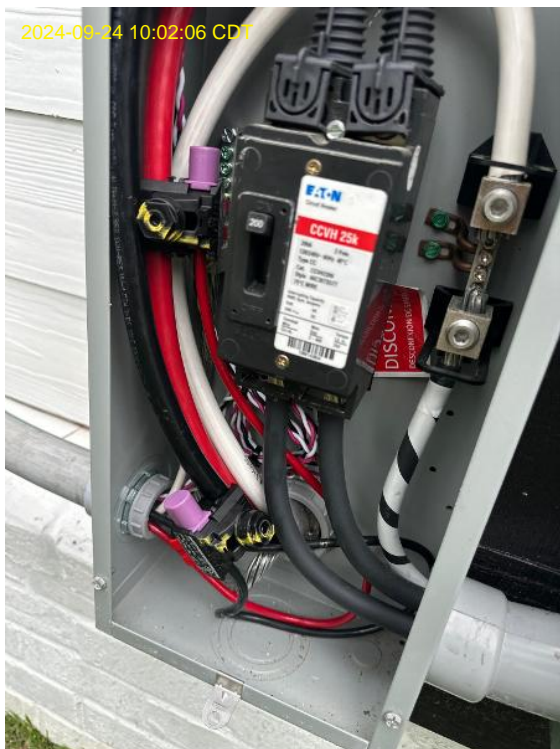

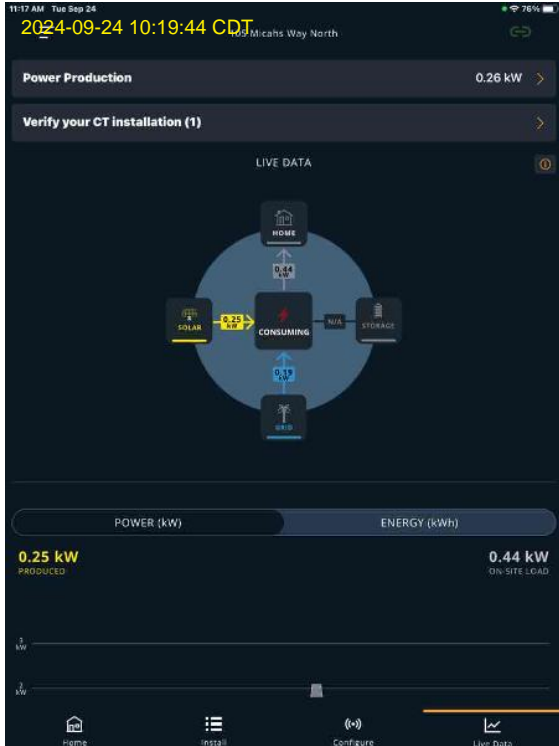

Commissioning / PV ON - Live Data (Solar, Consumption, & Grid in the commissioning app with the solar ON)



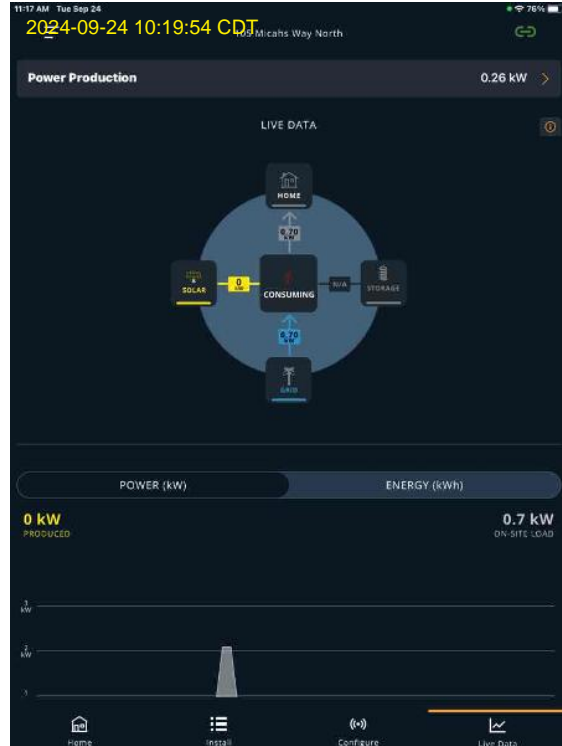
